If your business is registered in Montana, this quick guide will help you stay compliant heading into the 2026 filing season.

Your Montana Filing Window & Deadline

In Montana, **all LLCs and Corporations** must file an **Annual Report** each year to remain active and in good standing.

Key Dates:

Filing window opens: January 1, 2026

Annual report deadline: April 15, 2026

If your report isn't filed by April 15, the state considers it **late**, and continued non-filing can eventually lead to **administrative dissolution**.

Filing early helps you avoid penalties, backlogs, and last-minute stress. **Montana Filing Fees & Late Penalty**

 **Late fee (after April 15): \$15**
