With contributions from a diverse, multi-disciplinary team, organized through the NC DPI Exceptional Children Division Program Improvement and Professional Development Section, and with a review of the literature on best practices, co-teaching modules for both administrators and teachers have been designed, developed and are ready for release to our LEAs. These modules are regularly offered during the EC Division summer institutes and consistently receive very positive feedback.

The EC Division invites you to select and send a strong general education and special education pair, two individuals, representing your LEA, to join us on September 7, 2016, from 9am-3:00pm at the DPI offices at 301 N Wilmington Street, Raleigh, NC. The purpose of the time together that day is to provide an overview of the module content and discuss the plan for your representatives to instruct adult learners within your LEA.

The co-teaching module design team developed both a participant and an instructor manual with prepared notes, resources, articles, and video links for both the administrator and teacher audiences. An overview of the matching online modules will also be shared during the meeting.
