RE:

PSYCHIATRIC RESIDENTIAL TREATMENT FACILITIES (PRTFs)

APPROVED TO PROVIDE SPECIAL EDUCATION

The Individuals with Disabilities Education Act (PL 108-446) and Article 9 of Chapter 115C of the North Carolina General Statutes require that the Department of Public Instruction monitor and approve non-public schools and facilities that provide special education and related services to children with disabilities placed in a PRTF through the Local Management Entity (LME) / Managed Care Organization (MCO).

According to North Carolina legislation, licensed PRTFs shall ensure that educational services are provided to any child residing in the facility, including special education and related services to a student with a disability. Local Education Agencies (LEAs) and PRTFs must work collaboratively in the areas of information sharing, Child Find, reevaluation and transition at discharge.

All students with disabilities placed in PRTFs are entitled to the same rights and procedural safeguards as outlined in *North Carolina Policies Governing Services for Children with Disabilities*. These rights and protections include provisions that the students' IEP services are aligned to the general education curriculum and establish measures of performance and outcomes consistent with those of their nondisabled peers.
