Re: Session Law 2014-115, Section 62(b) of House Bill 1133

In 2013, the General Assembly of North Carolina enacted Session Law 2014-115, Section 62(b) of House Bill 1133 (see Attachment A), related to payroll deductions for payments to certain employees' associations. This bill requires certain employee associations to have minimum memberships in order to authorize a payroll deduction to be paid to the association. This bill also requires the Office of the State Auditor (OSA) to verify and certify annually the total membership count and the State, political subdivision of the State, or public school employee membership count of a domiciled employees' association. For that reason, we are requesting you provide the OSA a report containing your employees that made payments through payroll deduction to an employees' association for the December 2017 payroll period. We request that this include the employee name and employee association that received payment (please do not include Social Security numbers).

Below is a list of some of the employee associations that we are aware of at this time. If you have employees that have authorized payroll deductions to other employee associations, please include those in your report.

Attachment A

House Bill 1133:

SECTION 62.(b) G.S. 143B-426.40A(g), as amended by subsection (a) of this section, reads as rewritten: "(g) Payroll Deduction for Payments to Certain Employees' Associations Allowed. — An employee of the State or any of its political subdivisions, institutions, departments, bureaus, agencies or commissions, or any of its local boards of education or community colleges, who is a member of a domiciled employees' association that has at least 2,000 members, 500 of whom are employees of the State, a political subdivision of the State, or public school employees, may authorize, in writing, the periodic deduction each payroll period from the employee's salary or wages a designated lump sum to be paid to the employees' association. A political subdivision may also allow periodic deductions for a domiciled employees' association that does not otherwise meet the minimum membership requirements set forth in this paragraph. The total membership count and the State, political subdivision of the State, or public school employee membership count of a domiciled employees' association that has at least 2,000 members, 500 of whom are employees of the State, a political subdivision of the State, or public school employees, shall be verified and certified annually by the State Auditor.

An employee of any local board of education who is a member of a domiciled employees' association that has at least 40,000 members, the majority of whom are public school teachers, may authorize in writing the periodic deduction each payroll period from the employee's salary or wages a designated lump sum or sums to be paid for dues and voluntary contributions for the employees' association. The total membership count and the public school teacher membership count of a domiciled employees' association that has at least 40,000 members, the majority of whom are public school teachers, shall be verified and certified annually by the State Auditor.

An authorization under this subsection shall remain in effect until revoked by the employee. A plan of payroll deductions pursuant to this subsection for employees of the State and other association members shall become void if the employees' association engages in collective bargaining with the State, any political subdivision of the State, or any local school administrative unit. This subsection does not apply to county or municipal governments or any local governmental unit, except for local boards of education.
