The North Carolina Department of Public Instruction, Exceptional Children Division is pleased to announce a learning opportunity for Families/Teachers of students with Deaf-Blindness at the Embassy Suites in Greensboro on August 3-5, 2018. The conference will address innovative techniques and approaches to educating students with Deaf-Blindness, focusing on transition across the age span. Experts in the field of Deaf-Blind Education will present on selected topics.

Please duplicate and share this information with the family of any child that meets the criteria for Deaf-Blind (i.e., between the ages of birth and twenty-two who have a vision and/or hearing impairment). We encourage the team working with the child who has Deaf-Blindness to participate in the conference as well. The team approach will strengthen relationships, assist with communication, and encourage cooperation to achieve common goals. A team member may attend even if the family is not able to attend. The teacher will receive 1.5 renewal licensure credit for participating in the full conference (all day Saturday and Sunday morning). This invitation is also extended to the Exceptional Children Directors and related service personnel serving any student who is Deaf-Blind.

This conference is a benefit provided under the North Carolina Deaf-Blind Project Grant in collaboration with East Carolina University (Teacher Support Program) and the Exceptional Children's Assistance Center (ECAC). This conference will be provided to the family and team members at no cost. Meals and accommodations will be provided. Transportation will be the responsibility of the participants. While we hope to accommodate all registrants, please be aware that space is limited. Priority will be given to family/teacher teams but all families and teachers are invited to attend. If we reach capacity, a waiting list will be established.

Registration will be completed online. The deadline for registration is June 15, 2018.

It is expected that the parent will attend all sessions. If this is a hardship, a family member must contact Dottie Snyder to inquire about available options by June 15, 2018. We will provide childcare staff to direct activities during conference sessions and to assist the primary childcare provider if needed. It is expected that children participating in our activities will adhere to the rules set by staff for the safety of all participants. The designated childcare provider must be at least 18 years of age and capable of addressing the needs of the child. There will be organized activities for the children and an indoor pool will be available. Parents will need to sign a release absolving conference staff of any liability for injuries during childcare camp. The childcare provider will stay in the same hotel unit with the family or be assigned to a room with another conference participant. Please note that parents are responsible for administering medications.
