The NC State Improvement Project (NC SIP), through the Exceptional Children Division, is focusing on cultivating technical and adaptive leadership in the area of Adolescent Literacy. Regional Literacy Consultants will deliver the Adolescent Literacy Overview to school and district-level implementation teams on the dates scheduled below. The content for this overview includes critical components of adolescent literacy; operationalization of expected implementation in a district, school, and classroom; and frameworks of implementation science.
