PRESIDENTIAL SCHOLARS PROGRAM

The U.S. Presidential Scholars Program was established by President Lyndon Johnson in 1964, and, since that time, the program has honored over 7,500 outstanding high school seniors. The mission of the program is to recognize and honor outstanding high school seniors, and thereby encourage high attainment among all students.

Per the original Executive Order establishing the program, students are selected on the basis of outstanding scholarship. For most of the program's existence, nominees have been invited to apply for recognition based upon SAT or ACT scores. As the program has grown, candidates have been invited to apply in other ways as well. Beginning in 1979, outstanding students who demonstrated ability and accomplishment in the visual and performing arts or creative writing were added to the program. Since 2013, Chief State School Officers have been invited to nominate candidates from their states for the General component of the program. The program is also partnering with several recognition organizations that each nominate candidates for the General component of the program. And, beginning in 2016, outstanding students who demonstrate excellence in CTE were included for recognition.

During the 2019 U.S. Presidential Scholars General component student nomination process, 71 CSSO-nominated students were named semifinalists, and 23 CSSO-nominated students were named U.S. Presidential Scholars.

GENERAL COMPONENT NOMINATION REQUEST

I am asking each of you to nominate one student from your LEA who demonstrates outstanding scholarship as a candidate for the 2020 Scholars program. , All high school seniors graduating between January and June of 2020, who are U.S. citizens or legal permanent residents and who attend public, parochial, or independent schools, as well as those who are home-schooled, are eligible. The candidates will go through the application process, and as in the past, the 2020 U.S. Presidential Scholars will be selected by the Commission on Presidential Scholars and receive the Presidential Scholars Medallion at a ceremony in their honor in Washington, DC.

CAREER AND TECHNICAL EDUCATION (CTE) NOMINATION REQUEST

In addition to the general nominations, we are also asking each of you to nominate additional students from your jurisdiction to be included as candidates for recognition for excellence in CTE. This year, we request your nomination of up to five students in CTE. Please see the attachment for suggested criteria.

We are proud this still new component of the program will honor students “on the basis of outstanding scholarship and demonstrated ability and accomplishment in career and technical education fields.”

All high school seniors who are participants of a CTE program graduating between January and June of 2020, who are U.S. citizens or legal permanent residents and who attend public, parochial, or independent schools, as well as those who are home-schooled, are eligible. Candidates who are nominated and choose to apply, and whose applications are complete, will be reviewed by a committee of qualified individuals experienced in career and technical education. The committee will choose 60 applicants to be named as semifinalists. The 60 CTE semifinalist applications will then be reviewed by the Commission on Presidential Scholars. All 2020 U.S. Presidential Scholars will be selected by the Commission on Presidential Scholars and will receive the Presidential Scholars Medallion at a ceremony in their honor in Washington, DC.

Completed applications will be due in February, and Scholars will be announced at the beginning of May 2020.
