**\*\*Please be cautioned not to confuse local Maintenance of Fiscal Effort (MOE) with state level MOE officially referred to as Maintenance of Fiscal Support (MFS). The reporting timeline and requirements imposed on MOE and MFS differ. The NC LEA MOE reporting deadlines for the preceding year are submitted annually within the IDEA Grant System via an amendment in the fall. Currently, the LEA 2018-19 MOE should have been reported in the IDEA Grant System by September 30, 2019. **Failure to satisfy MOE requirements will result in the inability to access grant applications.****

**\*\*The 2018-19 MFS reporting deadline for NCDPI to submit the state level MOE (MFS) was delayed, not the reporting requirements of the LEAs. Future reporting, LEA 2019-20 MOE expenditure data, will be reported in the MOE submission due October 31, 2020. There is currently no waiver for LEA Maintenance of Effort from OSEP.**
