



## HERE'S WHAT YOU NEED TO KNOW.

Using a Flexible Spending Account (FSA).

What is an FSA? An FSA is an employee benefit that allows you to conveniently save money on your healthcare and dependent daycare expenses. You don't have to pay taxes on the money you contribute to these accounts, which results in more take-home pay for you. There are two types of Flexible Spending Accounts—you can enroll in one or both.

- Healthcare FSA—covers the healthcare-related items you purchase that your insurance doesn't cover—like laser eye surgery handages, sunscreen and contact
  - laser eye surgery, bandages, sunscreen and contact solution.
    - You can elect up to \$3050 for the plan year.
    - You will have full access to your funds on the first day of the plan year. (This account is prefunded.)
    - You, your qualifying spouse and dependents can use this account—even if they are not covered by your health plan.
  - **Dependent Care FSA**—covers things like childcare and elder care.
    - You can elect up to \$5000 for the plan year.
    - You will have access to the funds in your Dependent Care account as they are deducted from your account each paycheck.
    - Your child (under the age of 13), spouse or relative who qualifies and is physically or mentally unable to provide care for themselves is covered.

### PLAN INFORMATION

FSA Account

Plan year:

2023-2024

#### FSA Reimbursement Frequency:

Claims are processed daily; check & direct deposits issued daily

Healthcare FSA maximum:

\$3,050

#### Dependent Care FSA maximum:

\$5,000 per household or \$2,500 per spouse if filing separate tax returns.

#### Claim forms:

You may submit claims using a debit card, online via the FSA website, from your smart phone or tablet.

**Healthcare FSA:** Expenses must be incurred between 07/01/2023 and 09/13/2024.

**Dependent Care FSA:** Expenses must be incurred between 07/01/2023 and 09/13/2024.

Healthcare and Dependent Care FSA claims must be submitted by 09/30/2024.

#### Terminated employee claim filing deadline:

You will have until the end of the plan year to submit claims incurred while employed.

#### **Election changes:**

The IRS does not allow changes in your annual election unless you have a qualified change in status. You need to notify your employer within 30 days of any qualified status change.













## **ELIGIBLE FSA ITEMS.**

Save money pre-tax on these common healthcare expenses.

#### Examples of eligible expenses:

- Sunscreen (SPF 15+)
- Contact Solution
- Bandages
- Neck pillow
- Thermometer

#### Quick tips:

- · Keep your receipts in case you're required to provide further information.
- In general things that are hygienic or cosmetic in nature are not eligible. Examples include:

  - Toothbrushes
  - Toothpaste
  - **Toiletries**
  - o Veneers
  - Teeth whitening/bleaching
  - o Cosmetic surgery
