

In previous editions of the Capitol Tablet, the "landing page" of each bill and resolution has been linked on the left-hand side of each Tablet page. The link took you to an overview of information about a bill or resolution, including the text of differing versions, committee and floor votes, testimony, scheduled hearings and committee work sessions, and video of lawmakers discussing the bill.

Since work on many of the bills we have been tracking is completed, the bill or resolution link on the page's left-hand side has changed. If the Legislature's work on the bill is done, or if the governor has signed it, the link now goes to the final version of the bill. This is known as the "enrolled" bill, which is the copy that is signed by the governor and filed with the secretary of state's office. Its language includes any changes made to the bill before the final version was passed. The text of the enrolled bill is what ends up in the North Dakota Century Code.

Most of the enrolled bills will take effect this summer. Budget bills for state agencies take effect July 1, as do bills that change tax rates. Most other bills take effect Aug. 1.

There are exceptions. Sometimes a bill is approved with a specific effective date that is later in the year, or even in the following year.

A bill with an "emergency clause" takes effect when it is filed with the secretary of state. To qualify for an emergency clause, a bill must have two-thirds support from both the House and Senate.

At the end of the session, the Legislative Council, which is the research arm of the North Dakota Legislature, publishes a list of every bill that has been approved and signed by the governor, along with its effective date. The link to that page will be here. Right now, the link takes you to the effective dates of legislation that was approved during the 2023 session.

And so it goes, as Kurt Vonnegut used to say. The train keeps rolling!
