


## New Mexico Real Estate Commission Application Submission Guide


All Real Estate applications are required to be submitted using the online licensing portal, NMPlus.

1. Login to your NMPlus account. [https://nmrldpi.my.site.com/bcd/s/login/?language=en\\_US](https://nmrldpi.my.site.com/bcd/s/login/?language=en_US)  
Your username is your email address on file with the Commission. Select 'Forgot password' if you don't recall your password. Please check your "junk folder" if you don't receive your password reset email. 


**New Mexico Real Estate Commission**  
The New Mexico Real Estate Commission licenses Real Estate Associate and Qualifying Brokers and governs brokerage and related activities of real estate transactions. Select

**Real Estate Appraiser Board**  
The board licenses and regulates real estate appraisers and appraisal management companies in New Mexico. Select

- You will select the type of application you want to start from the application menu (shown below). The application selected will provide additional screens once in the application. Most applications will require the supervisory transfer authorization form to be completed and uploaded, form is located on the Commission’s website at <https://www.rld.nm.gov/boards-and-commissions/individual-boards-and-commissions/real-estate-commission/licensing-registration-and-renewal/>

**All applications with an active status require Errors and Omissions insurance coverage.**



**Associate Broker**  
An Associate Broker is an individual who works under the direct supervision of a licensed Qualifying Broker for a licensed Brokerage (trade name) company. Select

**Property Management Endorsement**  
Brokers intending to offer property management services for others must register with the commission and provide additional continuing education. This endorsement is required to be renewed with each renewal and for each license. Select

**Qualifying Broker**  
A Qualifying Broker can be supervisory or non-supervisory and is associated with a licensed Brokerage (trade name) company. Select

**Trade Name**  
Trade name (brokerage office) must be registered with the New Mexico REC. This application can be completed to create a trade name, request changes to a current tradename or to dissolve an existing brokerage. Select

**Transfer Application**  
An associate broker or qualifying broker working as an associate broker is required to be affiliated with a supervisory qualifying broker. Please complete this application to update your qualifying broker. Select

### **Associate Broker Application**

Associate Broker Applicants must identify if they will be applying by waiver or by initial application (exon the first screen. This will determine the application path. New Mexico does not license sales agents. To determine if your out of state Real Estate license qualifies for a waiver please submit an email to [rldrealestate.comsn@rld.nm.gov](mailto:rldrealestate.comsn@rld.nm.gov).



**Property Management Endorsement-** This must be completed for each license that will provide property management and at each renewal.

\* Please read carefully and select the appropriate choice that applies to you:

- I have an active Associate Broker license in New Mexico for which I am requesting the property management endorsement.

### **Qualifying Broker Application**

A Qualifying Broker that is applying for an additional license will select from the first two options. An Associate Broker that is applying by experience (Upgrade) will apply by the bottom two. An out of state applicant will have a different path based on the answer to the first question.

New Mexico does not license sales agents. To determine if your out of state Real Estate license qualifies for a waiver please submit an email to [rldrealestate.comsn@rld.nm.gov](mailto:rldrealestate.comsn@rld.nm.gov).

This application will be used when a Qualifying Broker is moving their entire office to a new trade name, address, etc. Every license impacted is required to submit a Supervisory Transfer Authorization form and is uploaded with the application.
