## 2021 Review


In looking at 2021 as a whole, we notice a few interesting details about our responses. Broken down into categories of "Fire", "Canteen", "Casework", "Traffic Control", and "COVID-19" we see where our efforts have been utilized. Since the team's inception, we have seen an steady incline of our traffic control reponses. This is a reflection of the partnerships we have developed with our local Law Enforcement agencies. The Van Wert Police Department utilized us to assist with traffic control on all local parades. The Sheriff's department requested us several times to help divert traffic due to an accident, downed powerlines, or during an active fire scene. In total, 1,098 volunteer hours were accumulated by our team last year in the area of traffic control.

COVID-19 consumed 24% of our run volume in 2021, mostly due to our interaction with the Van Wert Health Department's vaccination clinics. Our volunteers put in a total of 81 hours of service at these clinics, whether that be traffic control or sanitization of the stations within the building.

In response to fire scenes, our team served over 500 first responders, 23 families who had lost their home in a fire, totaling 1,257 volunteer hours from CERT.

In 2018, CERT began with 6 members. Through several recruitment campaigns, we are overwhlemed to report that we currently have 36 volunteer members.

## Donations

CERT relies heavily on the generosity of local organizations and businesses to continue to serve in our capcity. In addition to the Salvation Army, the Van Wert County Foundation receives all monetary donations that are brought in for family members. Collectivly in 2021, nearly \$4,000.00 was donated by the community of Van Wert to assist families during their loss.

Our media partners of Times Bulletin, Van Wert Independent and Ohio City's Pride have provided excellent services to us in the area of Press. When donations are needed, they request information as soon as possible so that donations can be aquired. Their ability to reach the masses has proven vital to our team's success.















## **COVID - 19**

### VACCINATION CLINICS



Beginning in January, the CDC began approving the use of vaccinations against COVID-19. In conjunction with the Van Wert County Health Department, CERT provided volunteers to handle traffic control and other administrative duties for 16 clinics, totaling 363 volunteer hours.

### OTHER COVID-19 MISSIONS



Each dosage of vaccine required to be placed in extreme cold storage. Beacause of this, the Van Wert County Health department was in need of dry ice almost weekly. In order to relieve the pressure of getting the required amounts of dry ice, CERT made numerous trips to Lima's Air Gas to maintain the required product at the Health Department. Team member Chris Bercaw put in 624 miles and a totral of 24 hours completing these missions. Thank you, Chris!
