Dear Matt,

Since the repeal of the Professional and Amateur Sports Protection Act in 2018, the NCAA has closely monitored the legalized sports betting landscape to understand the impacts it has on intercollegiate athletics. Specifically, the NCAA is deeply concerned about the dangers it poses to the health, safety and well-being of over 500,000 student-athletes and the integrity of NCAA competition.

One particular issue that troubles the NCAA is betting markets that center around many aspects of a student-athlete's individual athletic performance, otherwise known as player prop bets. While these types of bets are prohibited in many states with legalized sports betting, they are offered in Ohio. The NCAA national office contacted several Ohio Division I schools about challenges related to sports betting and their athletics departments. Those schools cited issues surrounding player prop bets, including multiple instances of harassment and other well-being concerns.

Last year, in response to our monitoring, we <u>announced multistate advocacy efforts</u> that seek to enhance sports betting laws and regulations across the country. We commend the state of Ohio, as much of the framework we are advocating for is modeled within the state, including the novel law that bans bettors who threaten sports participants.¹ Another item we are advocating for that is modeled in the Ohio laws and regulations² is the ability for the NCAA and its member institutions to "have a seat at the table" to address concerns around intercollegiate betting markets offered by licensed gambling operators.

Therefore, pursuant to Ohio Code OAC 3775-11-01 (D) — Sporting Events and Wager Types, we respectfully submit a request to you as the executive director to prohibit player-specific prop bets on intercollegiate athletics competitions.

The following summarizes good cause to restrict these types of wagers:

- The NCAA has seen a significant increase in reports of student-athletes being harassed by bettors, including reports from our member institutions in Ohio.^{3,4} Specifically, in 2023 alone, the NCAA became aware of six Division I student-athletes who reported harassment related to betting activity. The reports came through on-campus sports betting education sessions, which have been conducted at only a fraction of Ohio's college campuses so far. Sadly, this is occurring in many states across the country. In a recent NCAA survey of NCAA member schools, over 30 Division I institutions reported someone with a gambling interest harassing their student-athletes. Player prop bets attach an individual student-athlete's name to a bet and therefore increase the likelihood of betting harassment being targeted toward them.
- Player prop bets increase the risk of insider information being solicited and/or leveraged to manipulate betting markets.⁵ Student-athletes, unlike professional athletes, are accessible to other students and members of the public at large.
- Player prop bets may entice student-athletes into engaging in sports betting by *betting on themselves* to outperform a player prop bet related to their own game performance.

• Player prop bets increase the risk of "spot fixing," or would-be match fixers targeting student-athletes and other sporting participants to fix a portion of a contest without having to fix the whole contest.⁶

In addition to these compelling reasons related to intercollegiate athletics, gambling generally — and sports betting specifically — has been shown to be more addictive for college-aged individuals,⁷ and player prop bets offer a mechanism for college students to engage in "micro-betting," a more repetitive form of sports betting.
