

2024 SAFE ROUTES TO SCHOOL PROGRAM FUNDING (SFY25-28)

In June 2024, Ohio Governor Mike DeWine and Ohio Department of Transportation (ODOT) Director Jack Marchbanks announced \$8.5 million in grants to improve safety for K-12 students walking and biking to and from school in 19 counties. The below list of award recipients and project descriptions was compiled by ODOT.
