HB 123 Threat Assessment Evidence Based Training

Approval Request Form

Ohio Revised Code section <u>5502.263</u> requires the department of public safety, in consultation with the department of education and the attorney general, to develop and maintain a list of approved training programs for completion by school threat assessment team members prescribed in section <u>3313.669</u> of the Revised Code, one of which must be free or of no cost to schools. - (b) Moderate evidence from at least one well-designed and well-implemented quasiexperimental study; or
- (c) Promising evidence from at least one well-designed and well-implemented correlation study with statistical controls for selection bias.
