Purpose

An Excel document that serves two purposes

- 1) Provider submits its sites and schedules for approval
- Provider uses it to communicate with VR Staff about available slots and important details



Location

- Site Collection Tool will be located on OOD's website under the Provider page in the Provider Training folder
- Any changes to the service (work site, schedule, etc.) must be approved through <u>pcmu@ood.ohio.gov</u>
- For VR Staff and Contractors- the master list will be in a SharePoint document this year. They will not have to wait for a Friday email as in past years.



Flyers

- Providers can submit flyers to pcmu@ood.ohio.gov for approval.
 Approved flyers will be made available to VR Staff; the OOD logo cannot be utilized for service flyers
 - Please submit flyers only once
 - Please email as a PDF
 - Have someone else from your organization look it over before emailing it to OOD.



Submission Dates

- Completed site lists and SY Pre-ETS availability can be submitted on Monday, January 31 going forward
- The first SY site and information lists will be available to OOD staff and contractors starting February 14th
