Re: 2026 Audits of Oklahoma Government Entities

Dear Registrant:

Oklahoma Statute requires registrants, prior to engaging to perform an audit of an Oklahoma government entity, to register with the Oklahoma Accountancy Board (Board) and attest to being compliant with *Government Auditing Standards* continuing education and quality review requirements.

This is a courtesy reminder that these registrations must be renewed annually. There is no fee associated with this registration.

If your firm will engage to perform an audit of an Oklahoma governmental entity in 2026, you must submit the enclosed *Registration Form for Firms Who Perform Audits Engagements of Oklahoma Governmental Entities* to the Board. The form must **list each office location** that enter Oklahoma to perform audit of governmental entities. However, separate registration forms for each firm office is not required.

**Please note you will NOT need to complete and return the attached form if your practice neither currently provides, nor plans to provide in the future, attest services for Oklahoma governmental entities.**

Please note that your firm's application to be included on the Board's list of approved government auditors is not the same as the Approved School Auditors List, which can be accessed on the State Auditor and Inspector's website.
