**APPLICATION**


**COMES NOW** the Applicant and shows the Commission as follows:

**1. Parties:** That the Applicant is Robyn Strickland, Director, Oil and Gas Conservation Division, Oklahoma Corporation Commission, P.O. Box 52000, Oklahoma City, Oklahoma, 73152-2000.

**2. Allegations of Fact:** OAC 165:10-17-11 provides for a proration hearing to be held at least annually to establish the proration formula affecting unallocated gas wells, and that the Commission may hold additional proration hearings at shorter intervals if necessary. Pursuant to said rule, the Applicant has filed this application to establish the proration formula for the period of October 1, 2020, through March 31, 2021. The Commission's Oil and Gas Conservation Division will develop its recommendation regarding such formula after the public technical conference scheduled herein, and have its recommendation published under this cause number pursuant to OAC 165:10-17-11.

**3. Legal Authority:** 52 O.S. § 29 and OAC 165:10-17-11.

**4. Relief Sought:** Wherefore, premises considered, Applicant requests an order establishing the proration formula to be used in determining allowable production from unallocated gas wells for the period of October 1, 2020, through March 31, 2021.
