Due to Medicaid expansion as a result of federal legislation, this program is no longer necessary.

**Fiscal and Economic Impact:**

No fiscal or economic impact is projected. Closure of the OPHP division and the Healthy KidsConnect Private Health Option was approved by the legislature during the 2013 Session in HB 2240 and HB 2091, respectively. Abolishment of the administrative rules governing operation of the division is necessary to accomplish legislative intent, and has no additional fiscal or economic impact beyond what was incorporated in the fiscal and economic impacts described HB 2240 and HB 2091.

**Statement of Cost of Compliance:**

Repealing these rules will have no fiscal impact on state agencies, units of local government and the public.
