Fiscal and Economic Impact:

No fiscal or economic impact is projected. Closure of the OPHP division and the Family Health Insurance Assistance Program was approved by the legislature during the 2013 Session in HB 2240. Abolishment of the administrative rules governing operation of the division is necessary to accomplish legislative intent, and has no additional fiscal or economic impact beyond what was incorporated in the fiscal and economic impacts described HB 2240.
