Subject: Joint Meeting to Define *Device* for Advanced Estheticians and Estheticians

Introduction

The Health and Licensing Office (HLO) is hosting two in-person meetings at the [Oregon Garden Resort](#) in Silverton, Oregon.

- June 12, 2023, 9:00 a.m. to 4:00 p.m.: Joint Meeting of the Board of Cosmetology and Board of Certified Advanced Estheticians (Joint Board).
- June 13, 2023, 9:00 a.m. to 2:30 p.m.: Board of Cosmetology Meeting

The HLO had originally scheduled a two-day Joint Board meeting but due to issues with quorum the Board of Cosmetology will hold a regular board meeting on June 13, 2023, without the Board of Certified Advanced Estheticians.

June 12, 2023, Joint Board Meeting

The purpose of the June 12, 2023, Joint Board meeting is to review, consider and approve proposed rules related to esthetics and advanced esthetics. This will include reviewing the Joint Esthetic and Advanced Esthetics Rules Advisory Committee (Joint RAC) meeting reports, recommendation of rules and information related to fiscal impact. Rule changes are necessary to align with [HB 2970 \(2021\)](#) which passed during the 2021 Legislative Session. The bill made significant changes to both the Board of Cosmetology and the Board of Certified Advanced Estheticians statutes including changes to both professions' scope of practice and the requirement that both Boards work collaboratively to define the term "device" within esthetics and advanced esthetics. June 13, 2023, Board of Cosmetology Meeting

The purpose of the June 13, 2023, meeting is to reconcile current rules with proposed definitions related to devices and skin depth for estheticians, conduct regular board business, and provide a forum for community engagement and feedback for future rule changes.
