## RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.



**For willing and statutorily required renewal and private party title transactions emissions inspection verification is determined by the residence county.**

In RTS for renewals and private party title transactions NOT associated with a dealer GDN the emissions inspection requirements will be based on the residence county.

If no emissions inspection is found in the inspection database, and the customer is not exempt from the emissions inspection the clerk will need to manually verify the emissions inspection has been completed and select the appropriate emissions inspection on the Inspection Status INS001 screen.

If the customer is exempt from the emissions inspection due to a qualifying affidavit exempt reason or exempt vehicle class option, the clerk will select the new "EEI - Exempt from Emissions" on the INS001 screen to prompt the new "Affidavit Exempt Reasons" INS002 screen for a manual selection of an affidavit exempt reason. Upon selection of the appropriate affidavit exemption reason the clerk will continue processing the renewal and verify the emission fee was not displayed or collected. The clerk will also verify the \$7.50 Inspection Replacement Fee displays and is collected for non-commercial vehicles who were previously subject to a safety inspection.



**IVTRS Updates - Validate the county selected against the county displayed on the registration sticker.**

In IVTRS, upon renewal, the county of residence the customer selects must match the address on their registration sticker so that if the address is not on record, we can obtain a current and valid address to determine whether the customers live in an emissions county. Texas residents who live in emissions counties must obtain a passing emissions inspection and pay the applicable \$2.75 Emissions Inspection Fee prior to renewing registration unless exempt from emissions inspection.



If an applicable affidavit exempt reason is selected the customer will continue processing the renewal. The \$7.50 Inspection Replacement Fee displays and is collected for non-commercial vehicles who were previously subject to a safety inspection. Customers that fall under one of the new affidavit exempt reasons will not be charged the Emission Inspection Fee unless a passing emissions test is found in the inspection database. If an Affidavit Exempt Reason is selected it will be retained in our records for reporting purposes.

Customers who attest that they are out-of-state at the time of renewal will be charged the \$7.50 Inspection Replacement Fee. Customers who are out-of-state at the time of renewal must certify that they will obtain a passing emissions testing when they return to Texas. A "VERIFY INSPECTION" remark will be placed on the customer motor vehicle record requiring an emissions inspection to be completed and the payment of the applicable \$2.75 Emissions Inspection Fee upon returning to Texas.





**Update the Status Change Event - Inspection Status for out-of-state vehicles requiring emissions testing.**

Customers who previously certified they were out-of-state at the time of renewal and live in an emissions county must obtain a current passing emissions inspection upon returning to Texas to remove the "VERIFY INSPECTION" remark off their motor vehicle record. Once the customer has obtained the current passing emissions inspection the clerk will process the transaction in the Status Change event. The clerk will select the Inspection Status radio button on the "Status Change Record TTL006" screen and select the appropriate emissions inspection type on the "INS001" screen. The clerk will verify the \$2.75 Emissions Inspection Fee is charged. Upon completion of the emissions inspection requirement the "VERIFY INSPECTION" remark will be removed from the customers motor vehicle record.

**RRTS-35893****RTS Timed Permits - Remove all inspection requirements to allow permit issuance effective January 1, 2025.**

The inspection requirements have been removed within the system for the following permits:

- factory delivery permits
- One-trip permits
- 72-hr permits
- 144-hr permit
- 30-day permits

The department will no longer require inspection verification to process the permit transaction.



**RRTS-35985**

**Create a new emissions fee code - "Emissions Inspection Fee."**

The new "Emissions Inspection Fee" code & description is displayed, and the system will charge a fee of \$2.75 on payments screen and receipts when an emissions inspection is required.

In instances where an emissions inspection is required but the emissions inspection is not found in the inspection database the clerk may need to manually select the applicable emissions inspection type on the "INS001" screen.

The system is programmed to automatically charge the \$2.75 Emissions Inspection Fee if any of the following inspection types are selected:

1. TSI
2. ASM
3. OBD
4. EMONLY
5. TSI OBD
6. OBDNL
7. NLTSI

**RRTS-36077****Dealer (GDN) Title Transfer Transactions.**

Effective January 1, 2025, dealers submitting an application for title with registration for non-commercial vehicles are required to obtain a current passing emissions inspection within 180 days of the sale date and pay the \$2.75 Emissions Inspection Fee, if the vehicle is sold by a dealer in one of the 17 emissions counties.

For dealer title transactions processed in the purchaser, dealer, or lienholder county (statutory county) the emissions inspection requirement and verification are based on the processing county location. For dealer title transactions processed in any other county, the emissions inspection requirement is based on the dealer's county. Emissions inspections are still required in the following Texas counties:

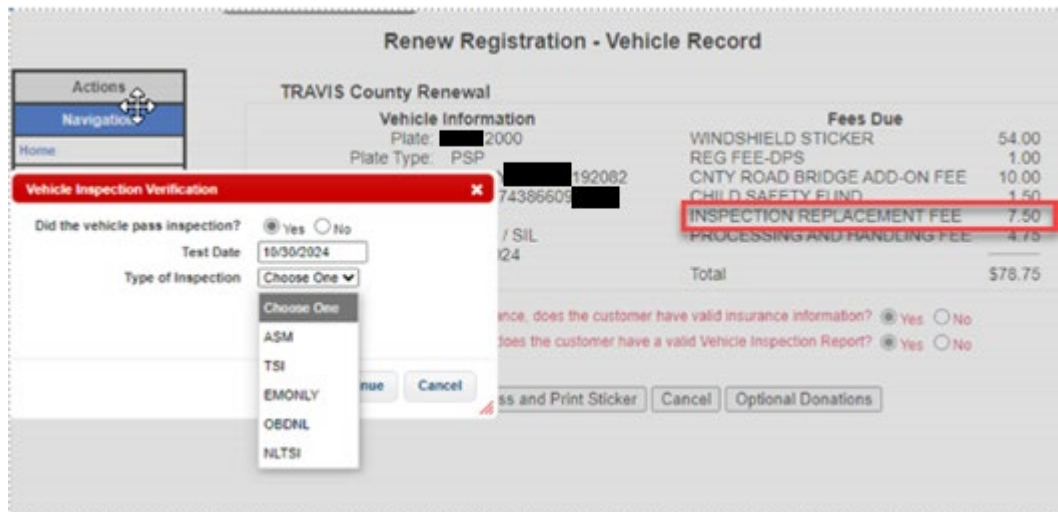

**IVTRS Update - Remove the self-certification page for travel trailers.**

IVTRS has been updated to remove the self-certification page for travel trailers due to the state inspection program being eliminated for all non-commercial vehicles statewide. With the state inspection program being eliminated, travel trailers will no longer be required to self-certify the trailer is in safe and proper working condition.



**RRTS-36461**

**Charge an "Inspection Replacement Fee" in place of the current inspection fee for all non-commercial vehicles.**

Effective January 1, 2025, the state inspection program is being eliminated for non-commercial vehicles statewide. This means all non-commercial vehicles will no longer be required to obtain a vehicle safety inspection prior to registration.

Owners of previously registered vehicles will pay an annual Inspection Replacement Fee of \$7.50. This fee will continue to be paid in addition to the vehicle registration fee.

Owners of new vehicles (current or preceding model year), that have not been previously registered in Texas or another state, will pay an initial Inspection Replacement Fee of \$16.75. Applicants who pay the \$16.75 fee are not required to pay the annual fee of \$7.50 for the same vehicle during the following registration year.

**“MOBILITY / CLEAN AIR FEE” has been renamed to “INSPECTION REPLACEMENT FEE”**

Currently, trailers, semitrailers, pole trailers, and mobile homes that have a gross weight or registered gross weight of more than 4,500 pounds but no more than 7,500 pounds are required to pay an annual fee (at registration) of \$7.50 per Section 548.510, Transportation Code, in lieu of paying such a fee to the State for previously required safety inspections of these vehicles. In RTS, this fee is currently identified with the account item code description “MOBILITY / CLEAN AIR FEE.”

“MOBILITY / CLEAN AIR FEE” will no longer be used to record incoming money after 12/31/2024. Vehicle types currently subject to the use of the “MOBILITY / CLEAN AIR FEE” will continue to pay the \$7.50 annual fee, under the new name of “Inspection Replacement Fee.”


