eLICENSING Overview

eLICENSING is an online self-service hub for all motor vehicle dealers, salvage dealers, and industry licensees operating in Texas. Dealers and licensees can access licensing information, submit license applications and payments, and track the progress of submitted applications. Members of the public as well as tax assessor-collectors may use eLICENSING to file complaints against dealers.

Business Reported Issues

- LACE-10204 Dealer Temporary Plates - Plates and Stickers App - Add New Dealer Temporary Plates to the eLICENSING Application Processes**
- Provides FRN & GDN Dealers the ability to order the new Dealer Temporary plates through the Plate and Stickers application so that the Dealer Temporary plates will be available for use on July 1st of 2025. The new Dealer Temporary plates will replace the Vehicle-Specific and Agent-Specific Dealer Temporary Tags.
- LACE-10975 Add Dealer Temporary Plates to "My Licenses & Plates"**
- Franchise and GDN Dealers will be able to view their active Dealer Temporary plates for their respective license in eLICENSING's "My License & Plates" main option.
- LACE-10976 Dealer Temporary Plates - Update the Packing List**
- Packing slips will be available for each plate type, Dealer Standard and Dealer Temporary, when plates are sent to the dealers.
- LACE-10977 Dealer Temporary Plates - Update the License Record**
- A new section as well as specific information regarding the new Dealer Temporary plates was added to the license record.
- LACE-11023 Dealer Temporary Plates: Calculate Sequence Plate for Temporary - Motorcycle**
- A zero will be added to the last place of the motorcycle dealer temporary plate sequence to complete the motorcycle dealer temporary plate sequencing pattern.
- LACE-11055 Update to the Independent (GDN) Motor Vehicle Dealers List Business Email Field**
- The 'Business Email' field on the Independent (GDN) Motor Vehicle Dealers List was updated to pull from the Business Email found on the License Record rather than the Business Email found on the Account Record.
