Data Management Center (DMC)

- The DMC has been updated to correct an issue where users were able to view and select the drop-down menu for the 'Select Year' option. Only one school year should be available in the DMC, so no selection should have been necessary.
- The DMC LEA Name drop-down menu has been updated to correct two issues.
 - The Organization name for some LEAs was displaying incorrectly.
 - Organizations with long names were being truncated where they should have been displayed on one line.
- The DMC 'Search Landing Zone' feature has been updated to correct an issue where the search results total on the bottom of the page did not match the actual results that were returned.



- The DMC has been updated to include the 'Export Data' feature, where users will be able to select and download one or more entities from the IODS that will include a daily update of the associated data elements in a CSV file.
- The DMC has been updated to correct an issue where the 'Add' button was appearing on the 'Manage Key and Secret' screen for users that should have had read-only access.
- The 'L2 Validation Rules Count' page in the DMC has been updated to correct two issues:
 - The breadcrumb path that is displayed on screen has been updated to include all screens that were included in the navigation.
 - The 'Monitor Validations' drop-down on the 'View L2 Validation Rules Count' tab has been updated to perform as it should.
- The 'Monitor Validations' screen in the DMC has been updated to correct an issue where an ESC was able to select the PEIMS Summer and Extended Year Submissions in the 'Collection/Submission' drop-down menu.

PEIMS Promotion Logic

- The PEIMS Fall Staff Employment Payroll Summary promotion logic has been updated to correct an issue where NumberDaysEmployed and PercentDayEmployed were not promoting. Following this software update, LEAs/ESCs will need to re-promote their data. FTEs will be calculated once these data elements are promoted.
- The PEIMS Fall Student Basic Information promotion logic has been updated to correct an issue where the Student Census Block Group was being promoted when the Economic Disadvantaged Indicator was not reported.
- The PEIMS Fall Student>Graduation Program promotion logic has been updated to correct an issue to only promote when the grade levels are equal to 09-12. This issue was causing rules 48011-0018 and 48011-0019 to fire when they should not have.
- The PEIMS Fall Student School Leaver promotion logic has been updated to correct:
 - An issue to promote '00' when IndividualGraduationCommitteeGraduateIndicator is 'false'.
 - An issue where the grade level was not promoting for the prior year leaver, triggering rule 40203-001.
- The PEIMS Summer Student>Basic Attendance promotion logic has been updated to align with TEDS

 - Add the new descriptor value '17' to CalendarType for PEIMS Extended Year only.
 - Add 'AND (ReportingPeriod equals '7', '8' or '9') AND (Calendar.CalendarType equals '16' or '17')' to the base promotion filter.
