- The Class Roster application has been updated to correct an issue where the Staff Category>Staff Basic Information was not showing the correct total for the number of records promoted.

### Class Roster Promotion Logic

- The Class Roster promotion logic has been updated to correct an issue where the Education Organization>Campus was incorrectly promoting the LEA's inactive campuses. This was causing rule 40110-0165 to fire incorrectly.

- The PEIMS Fall promotion logic has been updated to correct an issue where students that were being promoted without the IndividualGraduationCommitteeGraduateIndicator were triggering validation rule 40203-0005. The promotion logic has been updated to promote a '00' when no value is submitted.
- The PEIMS Summer promotion logic has been updated to align with TEDS 2025.2.1 that removed StudentCharacteristic 05 T-STEM from the StudentEducationOrganizationAssociation.
- The PEIMS Summer Student School Association promotion logic has been updated to promote two additional LocalEducationAgency.LocalEducationAgencyIds (220822, 061806) for the StudentCensusBlockGroup promotion.
