## **PEIMS Application**

- The Data Search tool has been updated for the PEIMS Fall Submission to:

  - Correct an issue where the 'Age on Sep 1' column was not displaying the correct age of the student.
- The Data Search tool has been updated for the PEIMS Summer Submission to align with:

Additionally, when the campus selected the 'Last Promoted On' link the server error was displayed.

## **PEIMS Promotion Logic**

- The PEIMS Fall promotion logic for the Adult Basic Education LEAs has been updated to correct an issue where graduates that have a Post Secondary Certification Licensure were not promoting (if earned between September and January) to the PEIMS Data Mart. The impacted LEAs are 227827, 220822, and 061806.
- The PEIMS Fall promotion logic has been updated to correct an issue where rule 40100-0040 was firing
  when the ADAEligibility (E0787) was not being promoted for a student that had more than one
  StudentSchoolAssociation entity record at different campuses where the EntryDate and
  ExitWithdrawDate overlapped.
  - Impact: If your LEA has this data scenario, you would have received the fatal validation, 40100-0040, and would not have been able to complete.
- The PEIMS Fall promotion logic has been updated to correct an issue where Interpreting Services was being promoted as a '0' instead of '00' when they did not report Interpreting Services.
  - Impact: The PDM1-121-002 Special Education Students by Disability was not displaying this data correctly on the Interpreting Services page of the report.
