Core Application

- The Core Search Submission Data functionality has been updated to correct issues for the:
 - Child Find application where CalendarCode was not displaying a number and/or text data types preventing the '*' wildcard search feature from returning any records.
 - Class Roster Winter application where Creditable Years of Service was not displaying a value for the promoted data.
 - SELA application where the:
 - DisabilityEligibilityDate was not displaying a value.
 - On-screen filtering option was only accepting an uppercase value when a name search was performed.
 - ECDS KG application where the:
 - Assessment Category was generating a configuration error message instead of providing data.
 - On-screen filtering option was only accepting an uppercase value when a name search was performed, and the 'Stu ID' filter was not functioning.
 - ECDS PK application where the:
 - Assessment Category was generating a configuration error message instead of providing data.
 - Campus Course Section was not displaying data for the PK Curr Cd.
 - Student>Enrollment (Programs) was not displaying data for SpEd data element.
 - On-screen filtering option was only accepting an uppercase value when a name search was performed, and the 'Stu ID' filter was only accepting alpha characters.

Data Management Center (DMC)

- The ESC-level DMC Load Summary and Validation Summary XLSX download functionality has been updated to correct an issue where the XLSX was downloading all LEAs within the ESC instead of the individual LEA that was requested.
- The DMC has been updated to correct an issue where large CSV export files (> 650MB) were receiving an out of memory exception when the user attempted to download the file.

ECDS Reports

- The following ECDS report has been updated to correct issues that occurred when the StudentSectionAssociation EndDates (E3020) and StaffSectionAssociation EndDates (E3020) were not populated.

- Student and staff demographic and course section data were being duplicated.
- Instructional start dates for staff were incorrect.
- Student assessment information was being duplicated.
- Student assessment information was displaying as 'null' on the report where the logic was using administration date falling between StudentSectionAssociation Begin and End dates.

PEIMS Application

- The XML Data Element Summary functionality has been updated to correct an issue where the PDF, XLS, and Print functions were missing from the application.

PEIMS Promotion Logic

- The PEIMS Summer Student > Special Education Program promotion logic has been updated to correct an issue, where LEAs were receiving fatal validation rule 41163-000C, because the application was not promoting the InstructionalSetting (E0173) data element.
- The PEIMS Summer Student>Special Education Program promotion logic has been updated to promote:
 - MultiplyDisabled (E0882) if the ProgramEndDate (E3048) is 'null' or after the first day of school. Additionally, if the current set has an end date, then the promotion will check for another instance where the ProgramEndDate (E3048) matches the ProgramBeginDate (E3047) from another set. If there is not another set, then the MultiplyDisabled (E0882) flag is set to '0.'
 - InstructionalSetting (E0173) if the InstructionalSettingEndDate (E3026) is 'null' or after the first day of school. Additionally, if the current set has an end date, then the promotion will check for another instance where the InstructionalSettingEndDate (E3026) matches the InstructionalSettingBeginDate (E3025) from another set. If there is not another set, then the InstructionalSetting (E0173) flag is set to 'null.'
- The PEIMS Summer Student>Special Education Attendance and Special Education Flexible Attendance promotion logic has been updated to not promote InstructionalSetting (E0173) '31', '32', '34', '40', '50', '60', '70', or '71'.
- The PEIMS Summer Student>Enrollment (Program)>Dyslexia Services promotion logic has been updated to correct an issue where DyslexiaServices (E1650) was not being promoted when there were numerous services with begin and end dates.
- The PEIMS Summer Campus Course Section>Course Section promotion logic has been updated to add that the Course (Reference) is eligible for high school credit, one of the TxVSN designated campuses, or LEA ID is '152504'.

- The PEIMS Summer Student>Disciplinary Action promotion logic for the DisciplineActionIdentifier (E1004) has been updated to increase the character length from 20 to 32 characters.
- The PEIMS Summer Student >Graduation Program promotion logic for FHSPParticipant (E3030), FHSPDistingLevelParticipant (E3029), and IndividualGraduationCommitteeReview (E1563) has been updated to consider the entire school year by including a '1' if it is true at any point in the school year else set to '0' if it is false at any point in the school year. If no value is reported, then set to null.
- The PEIMS Summer Student >Disciplinary Action promotion logic has been updated for DisciplineActionIdentifier (E1004) data element length increase to 32 characters to align with TEDS 2025.2.0

- The PEIMS Fall Reports Bundling functionality has been updated to correct an issue where immediately following the launch of a processing request, the bundle status was displaying as 'Completed' instead of 'In Progress.'
