## TSDS Web-enabled Data Standards (TWEDS)

- TWEDS search functionality has been updated with the following:
  - The system displays a tool tip when the user hovers over the search field.
    - The tool tip includes guidance on the use of quotation marks around a phrase to get precise results, an asterisk to search for parts of a word or phrase, and the ability to search for multiple terms by not including quotation marks or an asterisk.
  - Search results include all that match the prescribed search in six component categories: Data Elements, Descriptor Tables, Entities, Overview/ References/Early Notice, Rules, and Categories.
    - Search results with no values returned display 'Search Results (No results)'.
      - Search results with values returned display all matches with a number in the heading of each component category that indicates the number of matches, for example Data Elements (1) or Descriptor Tables (0).
  - Search results contain clickable links within each component category to information in TWEDS, such as rules, code tables, resource documents, etc.
