Census Block Group Tool

- The Census Block Group Tool (CBGT) has been updated to correct an issue where a change to the Environmental System Research Institute (ESRI) Geocoding Response Format created connectivity issues between the API/IODS and vendors.

- The View L2 Validation Rules Count screen has been updated to correct the following issues:
 - The 'Validations' hyperlink did not display after the validations were last completed.
 - The validations error 'Count' column in the chart did not display the correct total.



ECDS Reports

- The ECD0-000-0006 Early Childhood PK Data Submission report has been updated to correct the following issues:
 - The CalendarCode (E0975, formerly the INSTRUCTIONAL-TRACK-INDICATOR-CODE) was being displayed on the CSV version of the report when it should not have been.
 - Student and staff demographic data, course section information, and student assessment information were duplicated on the report.
 - Staff instructional start dates were incorrect.
 - Student assessment information was displaying as 'Null' or 'Not Assessed.'

PEIMS Application

- The PEIMS Data Statement of Approval process has been updated to include the following new PEIMS
 Summer Submission report that will autogenerate and require the PEIMS Data Approver to download and
 review prior to approving the PEIMS Summer Submission.

PEIMS Promotion Logic

- The Student>Career and Technical Program>CTEProgramSvcSet promotion logic has been updated to correct an issue with duplicate records by promoting the CTEProgramSvc (E3012) descriptors 7, 8, and 9, where the end date is 'null' or is after the first day of school.
- The Student>Course Completion promotion logic has been updated to align with TEDS 2025.2.2 which adds a the CourseTranscriptExt Entity that promotes the latest CourseAttemptResult (E0949).
 - The addition of this new entity corrects an issue with duplicate course completion records by:
 - Removing the promotion logic (previously communicated in the April 21, 2025 FCN Newsletter), that included the latest student, campus, and CourseAttemptResult (E0949) from the Course Transcript Entity and joined Session on TermDescriptorId to SessionName on the section.
 - Updating the CourseSequence (E0948) and SectionIdentifier (E1056) to the Student Academic Record Domain and the CourseTranscriptExt Entity.
 - Updating the DropoutRecoveryCourseCompletion (E3097), CollegeCreditHours (E1081), ATCIndicator (E1058), DualCreditIndicator (E1011), and CourseAttemptResult (E0949) to the CourseTranscriptExt Entity.
 - Additionally, TEA has updated all TEA-defined and custom claim sets with the CourseTranscriptExt
 Entity. Any custom claim sets that previously had access to the CourseTranscript Entity were given the
 same level of access to the CourseTranscriptExt Entity.

 (0) until your Student Information System (SIS) vendor has updated their software to align with TEDS
 2025.2.2 and is able to successfully publish data for the CourseTranscriptExt Entity.
