Census Block Group Tool (CBGT)

Core Application

The Core Application 'Promote Loaded Data' functionality has been updated to limit multiple promotions of

scheduled. The user will be given two options on how to proceed: 'Monitor Data Promotions' or 'Continue
with Promotions'.
