PEIMS Application

- The PEIMS Attendance 1st, 2nd, and 3rd Six Weeks Attendance (ATND) Submissions are now available for users to promote and validate their submission, as well as run reports and utilize the 'Access Data' features.

PEIMS Promotion Logic

- PEIMS Fall Student>Student Basic Information promotion logic has been updated to correct an issue that ensures students active as of the Fall Snapshot are promoted correctly, including cases with an ExitWithdrawDate (E3028) after the snapshot. This change:
 - Added: Promote when either condition is true:
 - The latest EntryDate (E1064) is within the current school year and on or before the PEIMS Fall Snapshot date.
 - OR
 - AsOfStatusLastFridayOctober (C324) = 'X' and the EntryDate (E1064) is within the current school year on or before the Fall Snapshot date and ExitWithdrawDate (E3028) is null or after the Fall Snapshot date.
 - Removed: The prior requirement to promote only when:
 - The EntryDate (E1064) is on or before the PEIMS Snapshot date and the ExitWithdrawDate (E3028) is null or after the PEIMS Fall Snapshot date.
- PEIMS Mid-Year>Education Organization>SSA Organization Association promotion logic has been updated to correct an issue where the PriorYearSSAOrgAssociationExt Entity was not promoting for ESCs.
- PEIMS Mid-Year>Finance>Actual promotion logic has been updated to correct an issue where the SharedServiceArrangementExt Entity was not promoting for ESCs.
