## Asthma Friendly Schools Training



Asthma is an inflammatory condition that impacts an individual's airways and breathing and affects **1 in 11** children and young people.

Children diagnosed with asthma are affected physically, emotionally, and academically. When asthma is not well managed, it prevents a child from effectively engaging in school and significantly increases the number of absences.



The Coventry and Warwickshire ICB, the local councils, and NHS providers have created a group dedicated to rolling out an accreditation.

We are asking all schools across Coventry and Warwickshire to sign up to the accreditation to enable staff working at these settings to have basic asthma awareness and knowledge of managing symptoms.



## WHAT DO SCHOOLS NEED TO DO?

School staff to complete Tier 1 training.  
Schools must meet the criteria to be an  
'Asthma Friendly School'.

Your school must then fill out a form so that  
we can ensure criteria have been met.

## ASTHMA FRIENDLY SCHOOL CRITERIA

- At least 85% of the staff employed by the setting have completed at least Tier 1 training Asthma training in the last 12 months.
- Have an Asthma Register for all children and young people who have asthma (confirmed or suspected)
- Each child to have a Personalised Asthma Action Plan at school (requested from parent/carers) (see resources section for template)
- Record and share information with parent/carers about the child's asthma whilst in school.
- Have an up-to-date Asthma Policy or Asthma section on the school's medical policy.
- Have a named Asthma Champion with specific responsibility and oversight of the school's Asthma Plan/Policy
- Have an emergency Inhaler Kit which includes compatible spacer.
- Ensure Asthma medications and spacers are easily accessible in the classroom.
- Have a plan for environmental disposal of inhalers.
- Recognise the impact of indoor and outdoor air pollution and allergen control.
