Promoting Independence in Devon

Our vision for people to live fulfilling lives as independently as they are able by being informed, secure and connected.

Living Well in Devon

For adults of working age to maximise their capacity for independent living, including autistic people, people with learning disabilities, mental health needs, physical disabilities, and sensory disabilities.

Ageing Well in Devon

Focuses on people's needs as they get older to sustain their capacity for independent living, including interventions that prevent, reduce and delay care needs.

Caring Well in Devon

Focuses on unpaid carers who look after a partner, family member or friend.

(Bot all people who fulfil a caring role recognise themselves as a carer or seek support.







Care Act (2014) duties:

- Market shaping: quality, choice, diversity, affordability, sufficiency; provider failure contingencies
- Provision of social care: assessment, support planning, financial assessment, arranging support, review
- Provision of preventative services and information/advice: reducing, preventing, delaying support needs
- Promotion of individual wellbeing
- Promotion of integration between health and social care services including integrated commissioning
- Safeguarding: safeguarding of adults at risk and system governance

A local authority must promote the efficient and effective operation of a market in services for meeting care and support needs with a view to ensuring that any person in its area wishing to access services in the market—

- (a) has a variety of providers to choose from who (taken together) provide a variety of services;
- (b) has a variety of high quality services to choose from;
- (c) has sufficient information to make an informed decision about how to meet the needs in question.

What is Market Shaping?



- Market shaping involves influencing and facilitating the care and support services market to ensure it meets the needs and preferences of individuals in the local area.
- It involves a range of activities, including market analysis, engagement with providers, and promoting diverse and sustainable services.
