# **New: Prevent Duty Guidance**

The Prevent Duty was published on 7<sup>th</sup> September 2023 and although the updated guidance places no new legal requirements or additional responsibilities on education settings, there are changes that the education sector should be aware of.

The updated guidance won't come into effect until 31st December 2023 at the earliest.

# <u>Safeguarding Shorts for DSLs / other SLT: Web filtering in 30</u> minutes

#### Overview

KCSIE 2023 has been published with a new focus on web filtering, including it being the lead responsibility of the DSL and lots of references to the new DfE Standards.

So join them for 30 minutes for an overview of what senior leaders need to know and need to do.

There is no need to panic and there are plenty of resources they can share with you to take away and improve your practice to make sure whether you are starting your journey or have already begun working closely on tech teams to ensure this safeguarding tool is strategically used in your community to support learners, keep children safe but not overblock.

### Consider:

- Do you know what you block or not and WHY?
- Is the rationale for what is blocked or not led by safeguarding and curriculum needs?
- Can you explain why you have 'appropriate filtering', how you meet the latest DfE web filtering standards or justify why you are not 'overblocking;?

# A message from Counter Terrorism Policing South East (CTPSE)

### Vulnerability to radicalisation (V2R)

As more students return to university and college in the South East, leaders in education are being reminded of the importance of knowing the signs of radicalisation and how to report any concerns they may have.

People can become vulnerable to radicalisation (V2R) if they, as a result of their situation or circumstances, could be drawn into supporting terrorism or extremist ideologies associated with terrorist groups.

If we are all aware of the risk factors, we will be better equipped to identify and refer vulnerable individuals to the Prevent programme. The programme can help those deemed to be at risk to get the support and early intervention needed to divert them away from a path that can lead to terrorism. To keep it really simple, reporting doesn't ruin lives, but it might save them.

We need to widen our gaze to consider V2R alongside awareness of other safeguarding risks such as domestic abuse, child sexual exploitation (CSE) or female genital mutilation (FGM) so we can spot the signs. The list below (not exhaustive) covers just some of of the potential indicators -

- · Isolation
- Marginalisation
- Identity confusion
- · Trauma
- Rejected by family or faith, & social group
- Grievance
- New network of online friends

- · Personal crisis
- Exposure to extreme views
- Shift in religious or political views
- Dangerous online activity
- Blaming others

If someone is vulnerable to radicalisation, they are unlikely to tell anyone or to reach out for support. Without help, they might go on to do themselves or society harm.

If you identify a V2R risk indicator in an individual's life, we need you to record those concerns and make a Prevent referral.

This enables professionals to intervene at an early stage and offer bespoke support to the individual. The earlier the intervention, the greater the chance of their being diverted away from the path that could lead to terrorism.
