## **Blog - Introduction from Alternative Provision Commissioning Manager**



I'm delighted to have joined PCC as Alternative Provision Commissioning Manager. I've always worked in roles that are centred around supporting young people.

Over the last 3 weeks, I've been meeting providers of alternative provision in and around Portsmouth. I've started compiling information ready to create an Alternative Provision Directory which will be accessible to schools and parents/carers once

published. I've also been working on a Quality Assurance Framework which will help us ensure the organisations we're commissioning have everything in place to keep children safe and deliver excellent services.

Over the next few weeks and months, I'll be finalising the quality assurance framework and starting to use this with our local providers. I'm also really looking forward to meeting staff from local secondary schools to find out more about their experiences of referring students to alternative provision settings and to work with them to shape the offer going forwards.

I had a brilliant meeting with staff from Portsmouth Parent Voice where I learned more about their work and how integral they will be in supporting the development of our work in the alternative provision space.

I'll also be setting up an Alternative Provision Provider Group with the aim of encouraging collaboration and best practice sharing amongst our partners. And I'm getting to work on organising an Alternative Provision Conference on 10 July. Further information and invitations to follow soon!
