Rotherham is now following COVID Alert Tier 2 - High restrictions which include:

<p>Social and family gatherings (home or garden)</p> <p>Do not meet with people from outside your household or support bubble indoors.</p> <p>Rule of six applies to outdoor gardens and parks.</p> 	<p>Public transport</p> <p>Face coverings must be worn.</p> <p>Where possible, cycle or walk.</p> 	<p>Indoor team sport</p> <p>Rule of six applies</p> <p>Maximum six players.</p> 	<p>Over 70s and medically vulnerable</p> <p>Shielding not in place.</p> <p>Follow guidelines to reduce risk.</p> 	<p>Indoor cultural venues</p> <p>Check with venue.</p> <p>COVID-19 restrictions in place.</p> 
<p>Bars, leisure and entertainment venues</p> <p>Closed between 10pm and 5am.</p> 	<p>Holidays</p> <p>Only with people who you live with or who are in your support bubble.</p> 	<p>Long-term residential care venues</p> <p>Social visiting suspended.</p> <p>Compassionate or critical visits allowed at care venue discretion – close family and friends only.</p> 	<p>Hospital visits</p> <p>Check with your local hospital.</p> <p>Restrictions may apply – close family and friends only.</p> 	<p>Religious venues</p> <p>Open.</p> <p>Some restrictions may be in place.</p> 
<p>Indoor Venues (including pubs and restaurants)</p> <p>Only meet with people who you live with or who are in your support bubble.</p> 	<p>Informal childcare with family or friends</p> <p>Those in support or childcare bubbles can look after children. Households outside these bubbles must not mix.</p> 	<p>Weddings</p> <p>Maximum 15 guests.</p> <p>Check with venue for further details.</p> 	<p>Schools and Adult/Higher Education</p> <p>Open.</p> <p>COVID-19 plans in place.</p> 	<p>Work inside homes (for Council or repair services)</p> <p>Permitted with COVID-19 safety measures in place.</p> 
<p>Public venues serving food and drink</p> <p>Table service only.</p> <p>Face coverings must be worn unless seated. Test and Trace information required.</p> 	<p>Childcare (separated parents)</p> <p>Childcare between separated parents can continue as normal.</p> 	<p>Funerals</p> <p>Maximum 30 mourners.</p> 	<p>Childcare settings (including childminders, after-school clubs and nannies)</p> <p>COVID-19-secure measures in place.</p> <p>Continue to use.</p> 	<p>Retail and close contact services (hairdressers, salons, etc)</p> <p>Open.</p> <p>COVID-19 restrictions in place. Face coverings must be worn.</p> 
<p>Takeaways</p> <p>Closed between 10pm and 5am.</p> <p>10pm to 5am delivery service only.</p> 	<p>Sporting Events</p> <p>No spectating for professional or semi-professional sports</p> 	<p>Workplace</p> <p>Work from home where possible.</p> <p>Travel to work in other areas allowed.</p> 	<p>Leisure centres, gyms and pools</p> <p>Open.</p> <p>Some restrictions in place.</p> 	<p>Enforced restrictions in place</p> <p>Limitations/restrictions in place</p> <p>Some changes in operation apply</p>
