

























ROTHERHAM COVID-19 RESTRICTIONS GUIDE

Rotherham is now following COVID Alert Tier 3 – Very high restrictions which include:

<p>Social and family gatherings (home or garden)</p> <p>Do not meet indoors or outdoors in private gardens with people not in your household or support bubble. Rule of six applies to parks and public gardens.</p> 	<p>Venue closures</p> <p>Betting shops, casinos and adult entertainment venues must close. Children's soft play areas must also close.</p> 	<p>Sporting Events</p> <p>No spectating for professional or semi-professional sports.</p> 	<p>Over 70s and medically vulnerable</p> <p>Shielding is not required unless you are advised to do so by your doctor.</p> 	<p>Schools and Adult/Higher Education</p> <p>Open. COVID-19 plans in place.</p> 
<p>Bars, leisure and entertainment venues</p> <p>Pubs and bars must close unless they serve substantial meals. Alcohol can only be served to people when eating.</p> 	<p>Public transport</p> <p>May continue to travel to open venues, but avoid journeys in or out of the Very High alert areas. Exceptions including work and school.</p> 	<p>Long-term residential care venues</p> <p>Social visiting suspended. Compassionate or critical visits allowed at care venue discretion – close family and friends only.</p> 	<p>Hospital visits</p> <p>Check with your local hospital. Restrictions may apply – close family and friends only.</p> 	<p>Indoor cultural venues</p> <p>Check with your venue. COVID-19 restrictions in place.</p> 
<p>Indoor Venues (including pubs and restaurants)</p> <p>Only meet with people who you live with or who are in your support bubble.</p> 	<p>Holidays</p> <p>Avoid staying overnight in another part of the UK. Further information is available for international travel.</p> 	<p>Weddings</p> <p>Maximum 15 guests. Receptions are not allowed. Check with venue for more details.</p> 	<p>Childcare settings (including childminders, after-school clubs and nannies)</p> <p>COVID-19-secure measures in place. Continue to use.</p> 	<p>Religious venues</p> <p>Open. Some restrictions may be in place.</p> 
<p>Public venues serving food and drink</p> <p>Table service only. Face coverings must be worn unless seated. Test and Trace information required.</p> 	<p>Informal childcare with family or friends</p> <p>Those in support or childcare bubbles can look after children. Households outside these bubbles must not mix.</p> 	<p>Funerals</p> <p>Maximum of 30 mourners (where covid safety measures are in place). Maximum of 15 people at a wake / celebration of life.</p> 	<p>Leisure centres, gyms and pools</p> <p>Leisure centres and gyms can remain open. COVID secure classes where households do not mix can continue.</p> 	<p>Work inside homes (for Council or repair services)</p> <p>Permitted with COVID-19 safety measures in place.</p> 
<p>Takeaways</p> <p>Closed between 10pm and 5am. 10pm to 5am delivery service only.</p> 	<p>Childcare (separated parents)</p> <p>Childcare between separated parents can continue as normal.</p> 	<p>Workplace</p> <p>Work from home where possible. Travel to work in other areas allowed.</p> 	<p>Retail and close contact services (hairdressers, salons, etc)</p> <p>Retail and close contact services open with COVID restrictions in place. Face coverings must be worn.</p> 	<p>Enforced restrictions in place</p> <p>Limitations/restrictions in place</p> <p>Some changes in operation apply</p>
