
We have had a slight increase in number of contacts to the last newsletter analysis in Q1 (Q1 2679 vs Q2 2711)


We have seen a decrease in the referrals to social care by half -12% in Q1 vs 6% in Q2.

Since this time last year, Q2 2024, we have seen an increase in contacts from 2249 in 2024 to 2711 in 2025.








There has been a decrease of 6% for outcomes to Level 3 support compared to Q1.










What is Families First Programme?

Aim: The aim of the Families First Partnership (FFP) programme is to transform the whole system of help, support and protection, to ensure that every family can access the right help and support when they need it, with a strong emphasis on early intervention to prevent crisis.

How: Four key areas, Strengthened Partnership Family Help (FH), with local Multi-Disciplinary Teams (MDTs) that wrap support around families to reduce escalating needs, where families are engaged in group decision making and their broader family network play a critical role in helping prevent crisis and where crisis does happen specialist Multi-Agency Child Protection Teams (MACPT) who are skilled to navigate complexity offer advice, support, challenge to help the care team.

- Our vision is a reformed system where Family Help Lead Practitioners (FHLPs), supported by expert multi-agency child protection teams (MACPTs) including social worker lead child protection practitioners (LCPPs), are responsible for and undertake direct child protection practice together with families where this is needed.
- When child protection concerns arise, FHLPs will maintain the relationship with the family and continue to coordinate the support and services for them.
- Where there are concerns about significant harm, the LCPP will take statutory child protection decisions with input from the wider (MACPT).
- The FHLP will remain involved in direct practice with the family throughout.
- There will be child protection expertise across the whole system of Family Help and multi-agency child protection, so effective action can be taken where concerns arise.

What is private fostering?

An arrangement made between a parent and a private foster carer without involvement of the local authority, to care for a child for more than 28 days. A private foster carer cannot be a close relative (grandparent, aunt, uncle or sibling) but can be someone who is known to the child. Local authorities have a duty to assess and support private fostering arrangements.

What is Private Fostering?

Private fostering is when a child under 16 (or under 18 if disabled) is cared for by someone who is not a close relative for more than 28 days. Close relatives include parents, step-parents, siblings, aunts, uncles, and grandparents. All other arrangements are considered private fostering. These can include children sent to the UK for education, children living with friends due to family breakdown, or teenagers living with the family of a boyfriend or girlfriend. Ukrainian Children under 18 years of age living in the UK without their parents are also defined as a Child/Young Person living in a Private fostering arrangement.

It is everyone's duty to inform the local authority of a private fostering arrangement. Private fostering is not the same as being looked after by the local authority – the arrangement is made privately by the child's parent(s) or person with parental responsibility.

How Does Private Fostering Work in Shropshire?


- Shropshire Council has a statutory duty to assess and monitor all private fostering arrangements to ensure the child's welfare is safeguarded.
- All Privately Fostered Children in Shropshire are automatically deemed a Child In Need under S17 of the Childrens Act 1989.
- The Fostering Team assess the suitability of these arrangements and provide advice and support to private foster carers.
- The Childrens Social Work teams conduct S17 social work assessments and then monitor these arrangements under a CIN plan.
- The number of private fostering arrangements in Shropshire remains low, but it is vital that all staff remain vigilant and report any potential arrangements.
- The process and responsibilities are outlined in our **<u>Statement of Purpose</u>** and **<u>procedures</u>**.



Is private fostering a type of kinship care?

The Government published a definition of kinship care in the National Kinship Strategy published in December 23. The definition includes private fostering arrangements where an individual(s) is caring for a child, not an organisation. So some types of private fostering are now considered a type of kinship care.


