

# **CIGIE LEADERSHIP FORUM**



On November 16, 2022, more than 3,000 members of the IG community gathered live online to participate in the 9th Annual CIGIE Leadership Forum entitled "Gearing Up: Leading Change to Make Our Work and Workplace More Effective, Innovative, and Impactful". The Leadership Forum is CIGIE's most widely attended professional development event and this year

participants from 68 of the 75 OIGs attended. For the third year in a row, the Forum was held virtually and included 13 leadership talks, featuring:

- A fireside chat with the Honorable Michael Horowitz, Inspector General for the U.S. Department of Justice OIG, the Honorable Jason Miller, Deputy Director for Management Office of Management and Budget and CIGIE Executive Chair, and Gene Sperling, White House American Rescue Plan Coordinator and Senior Advisor to the President
- An encore leadership talk from Robert Westbrooks, Executive Director of the Pandemic Response Accountability Committee
- A farewell to Forum co-chair, Elise Stein, Director of Intergovernmental Affairs for the U.S. Department of Health and Human Services OIG. After 25 years with HHS OIG, Elise retired from Federal service at the end of 2022. She helped create the CIGIE Forum concept, has co-chaired all 9 Forums, and has played a huge part in how it has grown and evolved over the years.

#### CIGIE FELLOWS PROGRAM

We are at the halfway mark of the 5th cohort of the CIGIE Fellows Program, and 22 of the 23 Fellows are working in their rotational assignments with another OIG or office, with the 23<sup>rd</sup> Fellow due to start their rotation in early 2023.

The Fellows have been meeting with their executive mentors and participating in developmental cohort activities throughout the year. Most recently, the Fellows participated in the CIGIE Leadership Forum in

November and a workshop in December on writing Executive Core Qualifications for the Senior Executive Service (SES).

Upcoming cohort activities include attending a HUD OIG hosted Deputy IG panel, a session to explore and understand behavioral and thinking characteristics, and the CIGIE Congressional Update class, which takes an in-depth look at the new Congress and related political dynamics impacting the Federal Government, to include the Federal budget.

The program began with an orientation in June of 2022 and will conclude in June of 2023 with a graduation ceremony. The CIGIE Fellows Program is offered every other year, which means that the next cohort will start in June 2024. We will begin planning for the 2024-2025 cohort later this year and will advertise the call for nominations in early 2024.

# CIGIE Executive Core Qualifications Review Board Program Pilot

The Leadership Innovation Subcommittee has wrapped up the 1st quarter of its CIGE Executive Core Qualifications (ECQ) Review Board Program Pilot and the 2nd quarter is underway with another round of fantastic volunteers from the IG community. Already considered to be a highly successful program, the Pilot has delivered on its goal to provide meaningful review and feedback on the draft ECQs of SES candidates (and some Senior Leader candidates) in the IG community. The 1st quarter Review Board reviewed 12 ECQ packages and the LIS has increased its capacity in the 2nd quarter to be able to review 16 ECQ applications. A

#### FY 2023 Coaching Updates

The PDC Coaching Subcommittee is completing the matching process for the fiscal year 2023 call for coaching participants. We received a remarkable 263 responses to the call! This represents an increase

from 180 responses in fiscal year 2022 and 154 responses in fiscal year 2021, underscoring the growing demand for, and awareness of, coaching as a valuable professional development service. Responses to the fiscal year 2023 call came from 42 OIGs, which represents about 57 percent of the OIG community. Of the 263 respondents, 47% were nonsupervisory employees, 30% were managers or supervisors, 18% were nonsupervisory team leads, and 5% were executives.

The Subcommittee is completing the matching of these participants with CIGIE coaches and Federal coaching partners (for those who indicated interest). Participants who responded to the call should expect to hear from the Subcommittee in early January 2023 with either a match or wait list notice. # CIGIE MENTORING PROGRAM

The CIGIE Mentoring Program pilot has come to a successful conclusion! On November 9th, the 6-month pilot program concluded with an event celebrating the 64 mentee and mentor participants. The celebration was filled with participant networking, reflections, and inspiring presentations from PDC Chair Rae Oliver Davis, Inspector General of the Department Housing and Urban Development; PDC Vice-Chair Cardell Richardson, Inspector General of the National Geospatial-Intelligence Agency; and George Scott, Deputy Inspector General of NASA.

The pilot project team is currently reviewing all participant feedback to incorporate into the next version of the CIGIE Mentoring Program, which will be launched in Spring 2023. The next phase of the program will expand on the already successful pilot in both size and programming.

In December, the CIGIE Mentoring Subcommittee welcomed CIGIE Fellow Drew Smith to the team. Drew will be supporting Subcommittee activities and focusing on sharing mentoring resources with the CIGIE community at large.

As the subcommittee continues to develop the next phase of the CIGIE Mentoring Program, as well as other mentoring initiatives, information will be posted to the CIGIE Mentoring webpage that is currently in development and coming soon!
