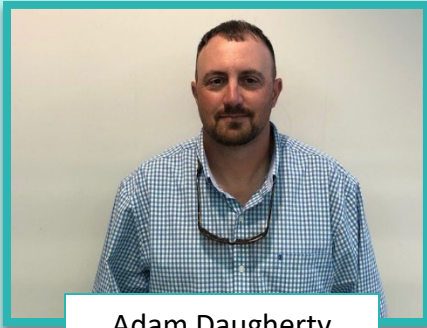

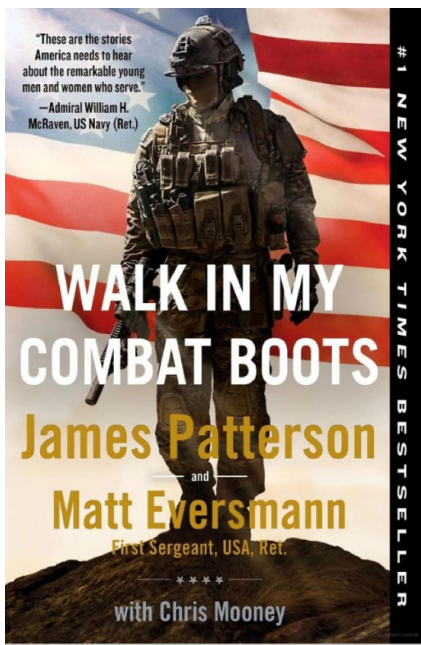

Veteran SEPM Update

I wanted to take a moment to provide some information on some upcoming events from the National Veteran Special Emphasis Program Manager Charles Thomas (acting).

Currently in the works are plans for a film screening, the creation of both a book club and a monthly Lunch and Learn series.

The Lunch and Learn is scheduled to begin in January and will be conducted monthly through Teams. This will be a meet and greet opportunity for networking within the FPAC mission area.

The book club will begin with [Walk in My Combat Boots: True Stories from America's Bravest Warriors](#) collected by James Patterson and 1SG (Ret.) Matt Eversmann. 100 copies of this book will be provided through FPAC. Details on the availability and meeting time are still to be determined.

The film [Terra Firma](#) is scheduled for screening in November. This documentary follows the story of three female veterans finding strength through the Farmer Veteran Coalition, using agriculture to combat the symptoms of Post Traumatic Stress Disorder.

What The PACT Act Can Mean For You

President Biden has signed the SFC Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act. This Act expands the number of conditions attributed to burn pit exposures and extends the period of enrollment with the VA Health care to ten years post-discharge.

Named in honor of Sergeant First Class Heath Robinson, a decorated combat medic who died from a rare form of lung cancer, this historic legislation will help deliver more timely benefits and services to more than 5 million veterans—across all generations—who may have been impacted by toxic exposures while serving our country. Danielle Robinson, the widow of Sergeant First Class Robinson, was a guest of the First Lady at President Biden’s [first State of the Union address](#) when he called on Congress to pass a law to make sure veterans devastated by toxic exposures – like her husband – finally get the health care and benefits they deserve.

The PACT Act will bring these changes:

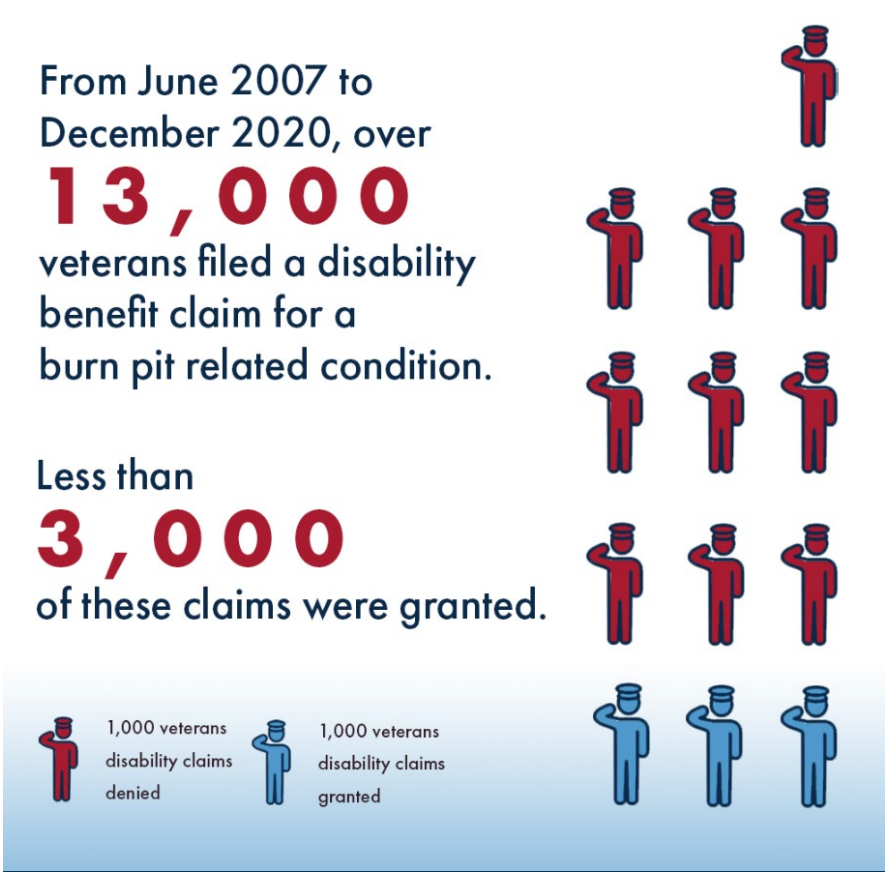
- Expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras
- Adds more than 20 new presumptive conditions for burn pits and other toxic exposures
- Adds more presumptive-exposure locations for Agent Orange and radiation
- Requires VA to provide a toxic exposure screening to every Veteran enrolled in VA health care
- Helps us improve research, staff education, and treatment related to toxic exposures

If you’re a Veteran or survivor, you can file claims now to apply for PACT Act-related benefits. Call the VA benefit line at 800-698-2411, reach out to your VA caseworker about VA Form 21-526EZ, or log into your VA.gov account to start your application. Clicking the Start your Application button will declare your intent to file. You have 1 year from the day you submit your intent to file to complete your application.

October was dedicated in 1994 by Rodney Wilson, a high school history teacher from Missouri, originally as a call to action to promote LBGT equality. October was specifically selected because it coincides with National Coming Out Day on Oct. 11th and the anniversary of Washingtons first ever LGBT civil rights march in 1979. The month also features Spirit Day on Oct. 20th, Ally Week in which we show support for the LGBT community, and the anniversary of 21-year-old Matthew Shepard’s murder on Oct. 12th. His death led to the Matthew Shepard and James Byrd Jr. Hate Crimes Prevention Act in 2009. 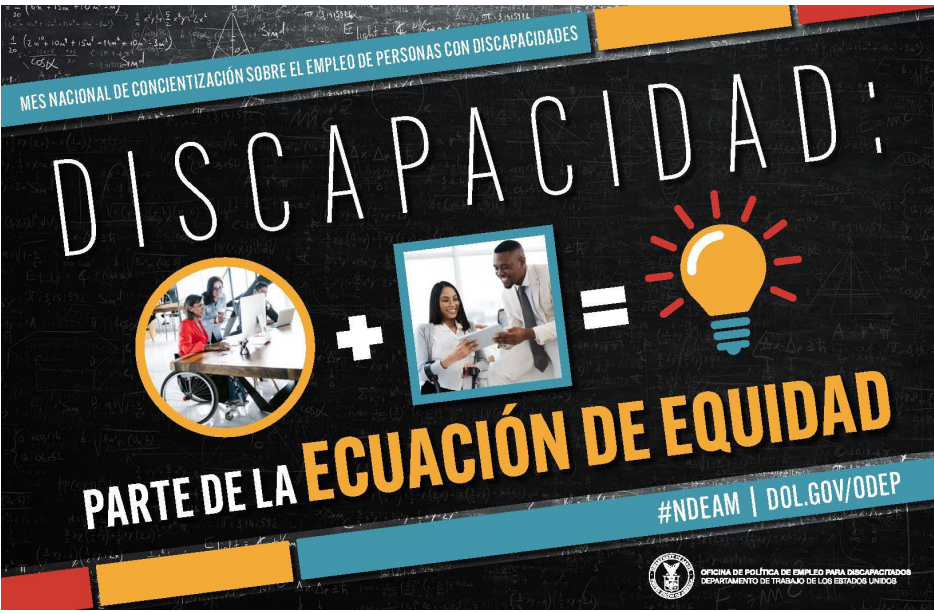
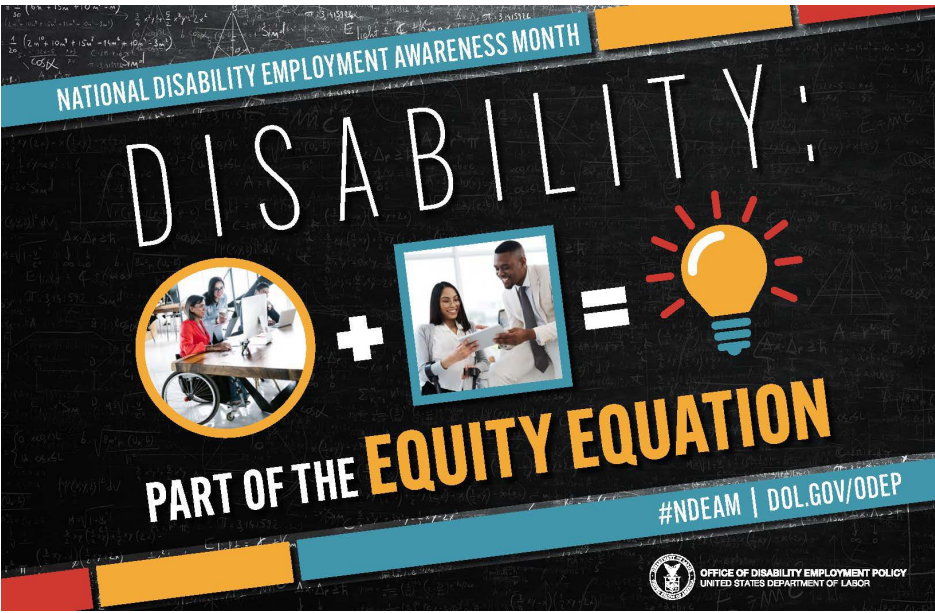
