# TRAIL CLOSURE Eagles Nest Trail # 111 For Public Safety

### **PROHIBITIONS**

Pursuant to 36 CFR 261.50 (a) and (b), the following act is prohibited on the National Forest System Trail described in this Order, within the administrative boundaries of the Cascade Ranger District, Boise National Forest. This Order will be in effect beginning October 17, 2018 and shall remain in effect through November 1, 2018, unless rescinded earlier by the Forest Supervisor.

1. Being on the Trail described below. 36 CFR 261.55(a)

## **EXEMPTIONS**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

- 1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
- 2. Any Federal, State, or local law enforcement officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Federal or State administrative personnel in the performance of an official duty.

#### TRAIL DESCRIPTION

National Forest System (NFS) Trail #111 (Eagles Nest Trail) is closed to all public use beginning at State Highway 22 (Warm Lake Highway), located in Township 14 North, Range 4 East, Section 21 and continuing to the NFS Property boundary located in Township 14 North, Range 4 East, Section 21, Boise Meridian.

The above described Trail as shown on the attached map attached hereto as Exhibit A, is within the Cascade Ranger District, Boise National Forest, Boise Meridian, Valley County, ID.

#### **PURPOSE**

The section of Trail described above will be impacted by prescribed burning operations. The Trail is closed to all public entry for public safety and protection from hazards associated with that prescribed fire.

#### **IMPLEMENTATION**

- 1. This Order will be in effect beginning October 17, 2018 and shall remain in effect through November 1, 2018, unless rescinded earlier by the Forest Supervisor.
- 2. A map identifying the above-described Trail is attached to and made part of this Order.
- 3. Any violation of this Order is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, and/or imprisonment for not more than six months [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].
- 4. This Order supersedes any previous Orders/notices for the above-described Roads or portions thereof.

## **Assessment of Need and Enforcement Plan**
