Dear Tribal Leaders,

The Department of Homeland Security (DHS) would like to consult with you on homeland security-related efforts being developed that are important to you and to the economic security of the United States in Alaska and the Arctic region, including the impacts of climate change.

The consultation will include an update on the Strategic Approach for Arctic Homeland Security and an overview of the Department's most recent thinking on this topic.

To be considerate of the weather and travel limitations, I would like to initiate consultation in this first round virtually and we plan to conduct more in-depth in-person consultations in the spring. Three opportunities are scheduled to participate in the virtual consultation.

- What additional impacts do you believe climate change will have on your communities over the next few years?
- Are you aware of existing DHS resources available to your communities? How can the Department of Homeland Security improve its outreach to inform Alaska Native communities about our mission in Alaska and the Arctic?
