Section 8E Regulations for Potatoes, Onions, and Tomatoes Imported from Canada – FAQs

When can loads of potatoes, onions, and tomatoes imported from Canada into the United States be certified as meeting import requirements?

Loads of potatoes, onions, and tomatoes can be certified either prior to import into the United States or upon arrival at destination within the United States. Certification must be completed prior to the load entering the United States stream of commerce.

Who can certify loads of potatoes, onions, and tomatoes imported from Canada into the United States as meeting import requirements?

Only the Canadian Food Inspection Agency (CFIA), authorized Canadian – Partners in Quality (C-PIQ) for potatoes only, and Federal or Federal/State United States Department of Agriculture (USDA), Agricultural Marketing Service (AMS), Specialty Crops Program (SCP), Specialty Crops Inspection Division licensed inspectors can certify the loads as meeting the grade, size, quality, and maturity import requirements.

What Section 8e import requirement inspection certificates are acceptable?

The Canadian Food Inspection Agency E-2, E-3, and C-PIQ (for potatoes only) and the USDA FV-E300. FV-E301, SC-300, and SC-301 are the only acceptable inspection certificates to certify the loads as meeting the grade, size, quality, and maturity import requirements.

What potatoes, onions, and tomatoes are regulated under Section 8e, what are the import requirements for each, when, if any, are the exempt periods and all exemptions to the import requirements?

When can loads of potatoes, onions, and tomatoes imported from Canada into territories of the United States be certified as meeting import requirements?

Loads of potatoes, onions, and tomatoes can be certified either prior to import into the United States or upon arrival at destination within the United States. Certification must be completed prior to the load entering the United States stream of commerce.

Who can certify loads of potatoes, onions, and tomatoes imported from Canada into territories of the United States as meeting import requirements?

Only the Canadian Food Inspection Agency (CFIA), authorized Canadian – Partners in Quality (C-PIQ) for potatoes only, and Federal or Federal/State United States Department of Agriculture (USDA), Agricultural Marketing Service (AMS), Specialty Crops Program (SCP), Specialty Crops Inspection Division licensed inspectors can certify the loads as meeting the grade, size, quality, and maturity import requirements.

Are loads of potatoes, onions, and tomatoes imported from Canada into territories of the U.S. required to meet import requirements?

Yes. Imports of potatoes, onions, and tomatoes from Canada into territories of the U.S. are held to the same standards as imports from Canada into the U.S.

What Section 8e import requirement inspection certificates are acceptable?

The Canadian Food Inspection Agency E-2, E-3, and C-PIQ (for potatoes only) and the USDA FV-E300. FV-E301, SC-300, and SC-301 are the only acceptable inspection certificates to certify the loads as meeting the grade, size, quality, and maturity import requirements.

What potatoes, onions, and tomatoes are regulated under Section 8e, what are the import requirements for each, when, if any, are the exempt periods and all exemptions to the import requirements?
