<u>PURPOSE</u>: This Trade Information Notice is to inform trade stakeholders that on Saturday, April 27, 2024, the Texas Department of Public Safety (DPS) has commenced Enhanced Safety Inspections on all commercial operating vehicles (COV) exiting the Ysleta Port of Entry, Commercial Cargo Facility, El Paso, Texas. This operation may expand to other El Paso Field Office (EPFO) cargo facilities and will affect wait times and the flow of COV making entry into the U.S. The duration of these enhanced inspections by DPS is unknown.

U.S. Customs and Border Protection (CBP) is committed to transparency and will continuously assess the situation. Updates regarding additional contingency plans will be provided as they become available.
