

Importer's Additional Declaration Grouping

The Importer's Additional Declaration Grouping contains information required for the reporting of additional, supporting declaration information and is **CONDITIONAL** for an Entry Summary LINE ITEM Grouping. The Importer's Additional Declaration Detail (54-Record) may be reported up to 9 times per Line Item.

Importer's Additional Declaration Detail (Input 54-Record)

The 54-Record contains a reference to a single Importer's Additional Declaration. The 54-Record is **MANDATORY** for an Importer's Additional Declaration Grouping. Do not submit if not required.

The following information is conditionally required to designate whether the Entry Summary line is accompanied by an Importer Certification for ship-to-shore cranes that are fulfilling in whole or in part an executed contract for sale dated prior to May 14, 2024. Goods must be entered for consumption, or withdrawn from warehouse for consumption, in the United States prior to May 14, 2026.
