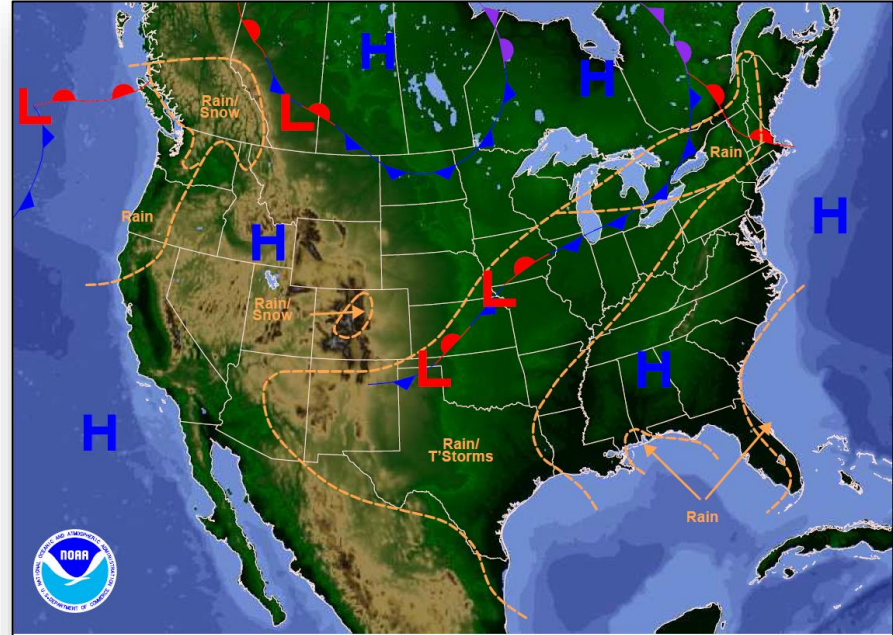

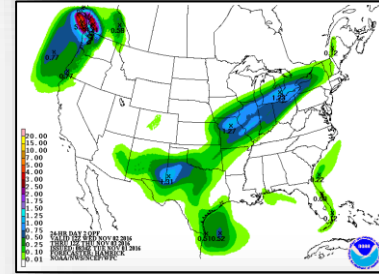
Precipitation Forecast – Days 1-3



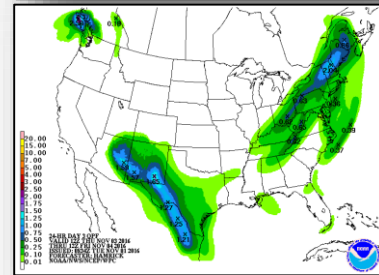

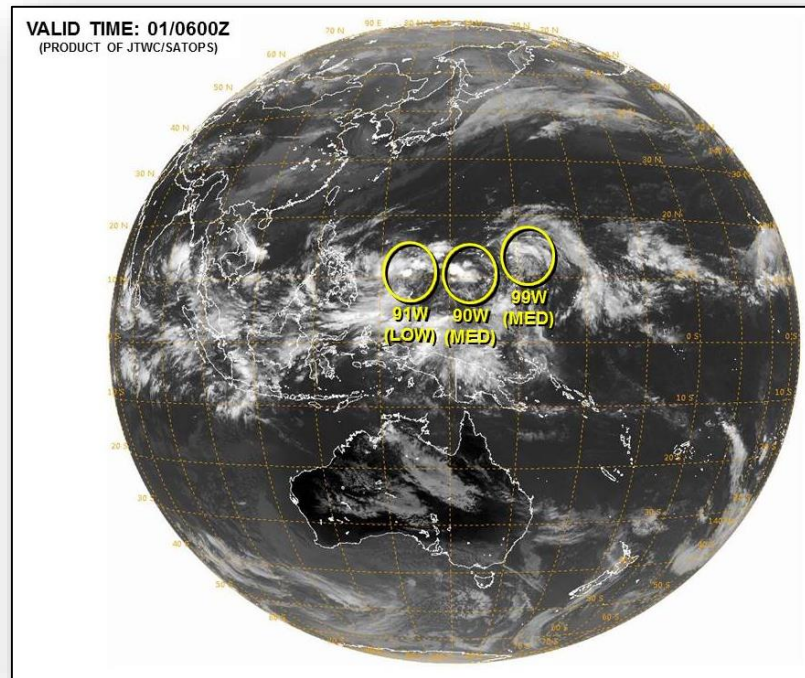

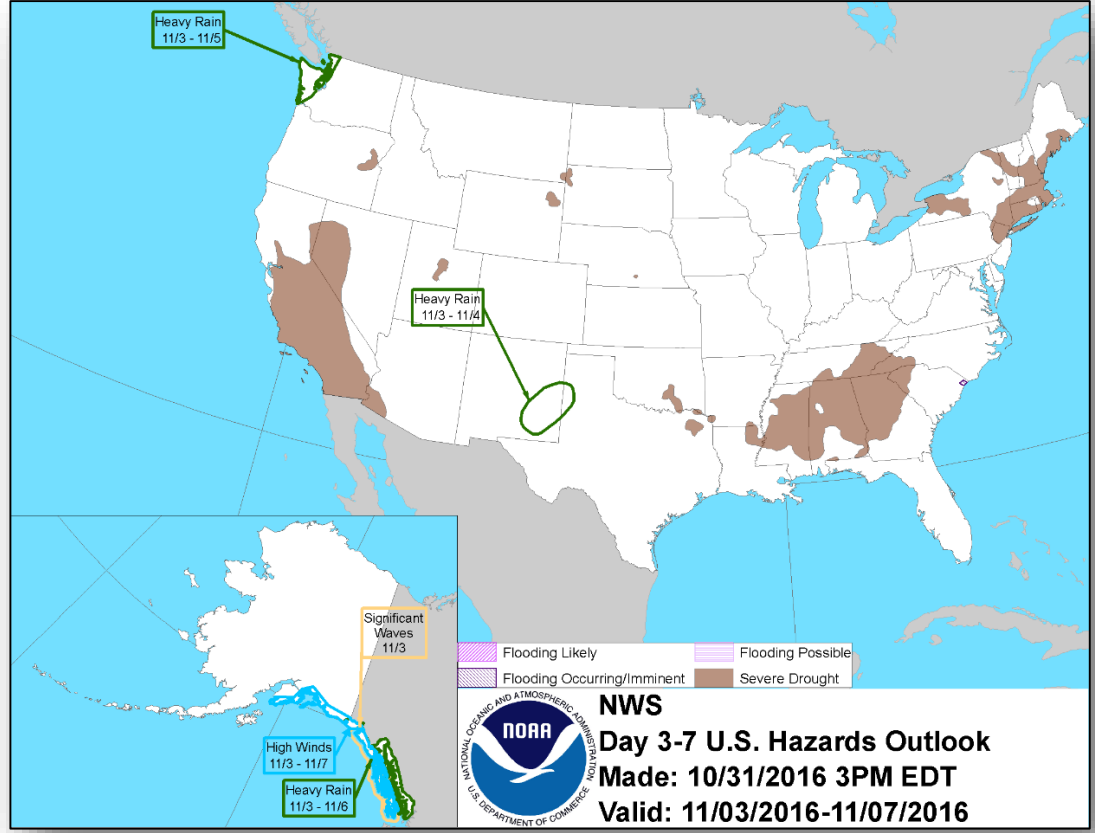

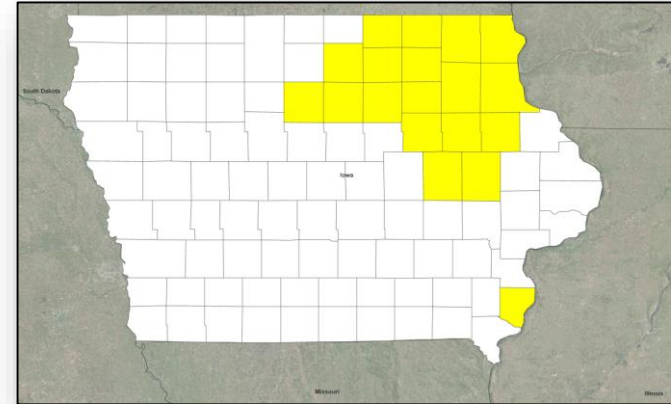


Declaration Approved

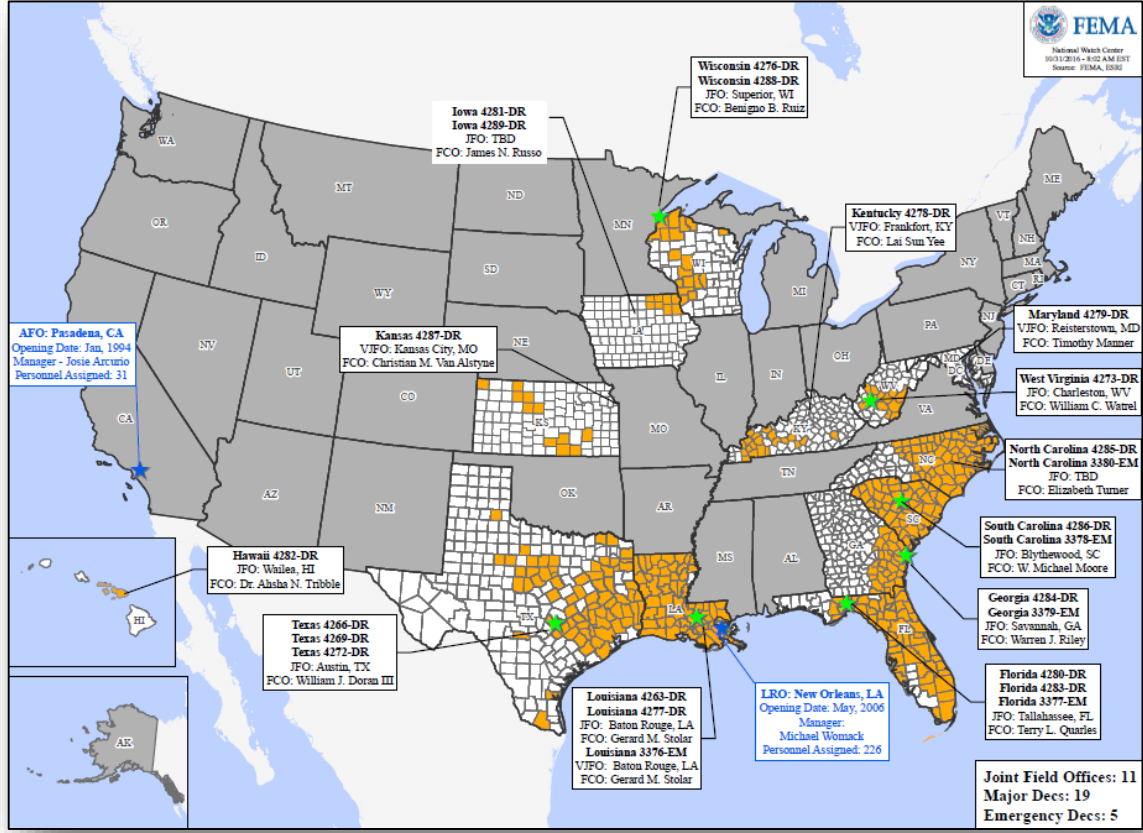

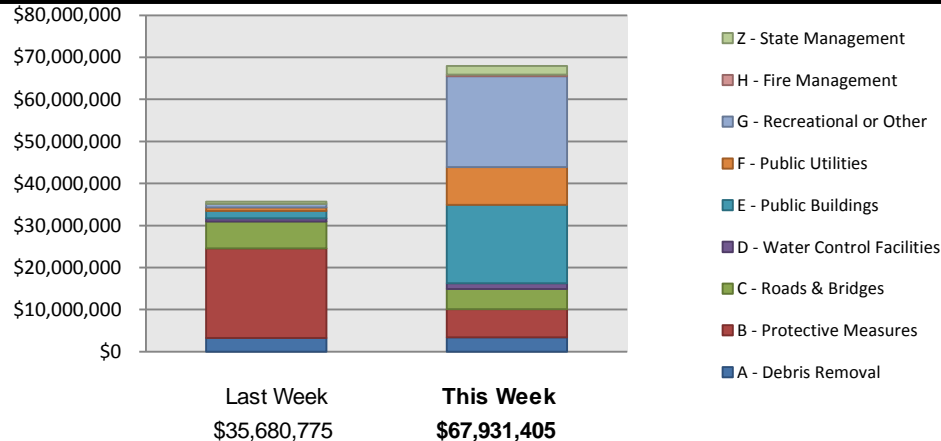

Public Assistance Obligated per Category In the Past 2 Weeks – 10/17/2016 through 10/31/2016



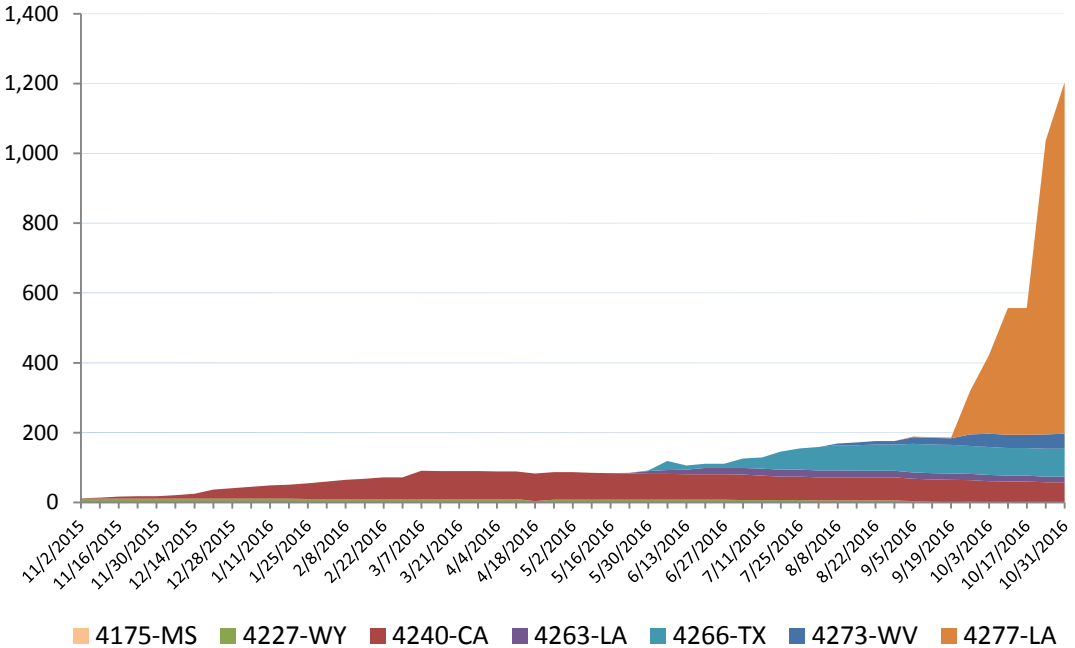

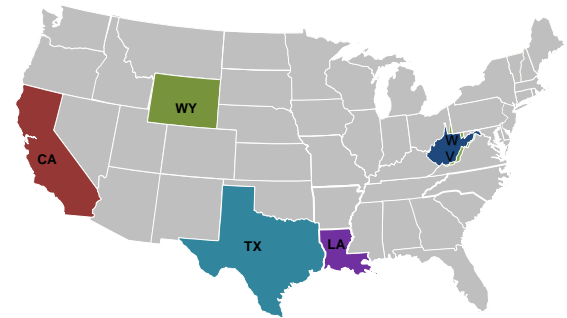

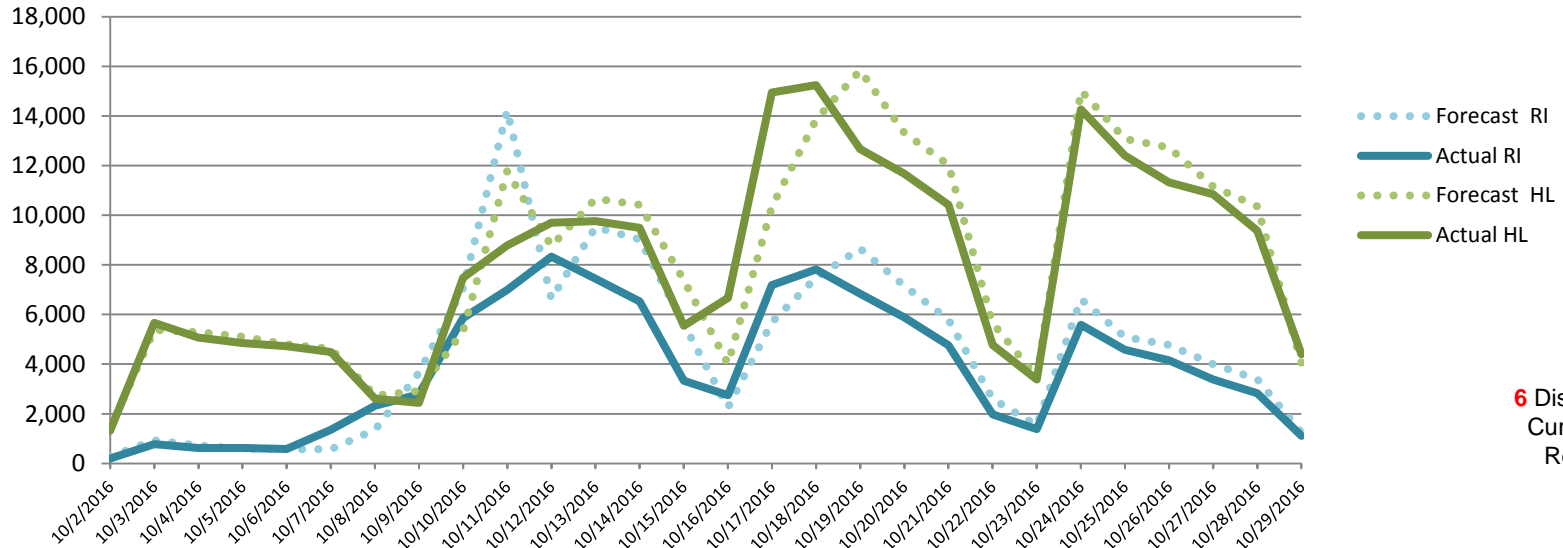

NPSC Call Forecasting and Actual Calls Over the Past 4 Weeks

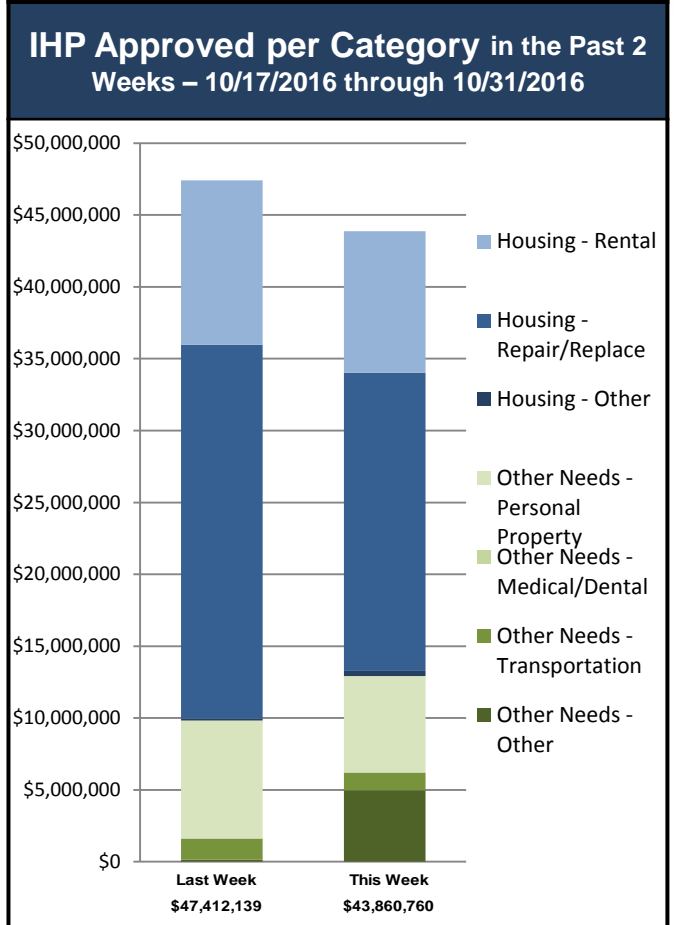
