- Heavy snow possible Northern Intermountain, Sierras and Central Rockies
- Rain and snow Pacific Northwest to central CA, Central Great Basin, and Northern Rockies; Southern/Central Rockies to Central/Northern Plains; Northeast
- Rain Pacific Northwest to central CA
- Critical/Elevated Fire Weather AZ, NM, TX & OK
- Red Flag Warnings NM, TX & OK
- Space Weather past 24 hours: none observed; next 24 hours: minor geomagnetic storms reaching G1 level likely




#### National Weather Forecast




#### Severe Weather Outlook – Days 1-3





#### Severe Weather Outlook – Days 4-5








#### Precipitation Forecast – Days 1-3













#### 6-10 Day Outlooks








6-10 Day Precipitation Probability


