Significant Activity – Apr 2-3



Significant Events: Severe Weather - Southern Plains to Southeast

#### Significant Weather:

- Severe Thunderstorms and Flash Flooding Lower Mississippi Valley, Southeast, and Mid-Atlantic
- Rain and Thunderstorms Southwest, Central Plains through the Mid-Atlantic, and Southeast
- Heavy Snow Central Rockies
- Space Weather:
  - $\circ~$  Past 24 hours: Moderate Radio blackouts reaching R2 level occurred
  - $\,\circ\,$  Next 24 hours: Minor Radio blackouts reaching R1 level expected

Tropical Activity: No activity affecting U.S. interests

Earthquake Activity: No significant activity

- Major Disaster Declaration requested ID

### Severe Weather – Gulf Coast



#### **Current Situation**

- Severe thunderstorms expected to continue through today
- SPC published 10 preliminary tornado reports

#### Impacts

- No significant or widespread damage reported; assessments ongoing Two confirmed fatalities in St. Martin Parish, LA due to an EF-1 tornado
- One injury reported in Franklin Parish, LA
- Customer power outages (Eagle-I Update, 7:48 a.m. EDT, April 3, 2017)
  - Region IV: 25k region wide (MS/23k)
  - Region VI: 36k region wide (TX/2k, LA/28k, AR/6k)
  - Four schools in Rapides Parish, LA closed due to power outages























### 6-10 Day Outlooks





6-10 Day Temperature Probability





6-10 Day Precipitation Probability



#### <u>Idaho</u>


- Governor requested a Major Disaster Declaration on March 30, 2017 for the State of Idaho

  - Hazard Mitigation statewide
- FCO is Timothy J. Scranton


