Significant Activity – May 10-11



Significant Events: Hanford Nuclear Site - FINAL

Significant Weather:

- Severe thunderstorms possible – Southern Plains to Mid-Atlantic
- Flash flooding possible – Southern Plains to Lower/Middle Mississippi and Tennessee valleys; Central Appalachians
- Rain and thunderstorms – Pacific Northwest; Northern Intermountain to Northern Rockies; Southern Rockies to Lower Mississippi Valley and Mid-Atlantic
- Rain and snow – Northern Intermountain to central CA; Central/Southern Rockies
- Critical/Elevated Fire Weather areas – FL & GA
- Red Flag Warnings – FL
- Space Weather:
 - Past 24 hours: None observed
 - Next 24 hours: None predicted

Earthquake Activity: No significant activity

Current Situation

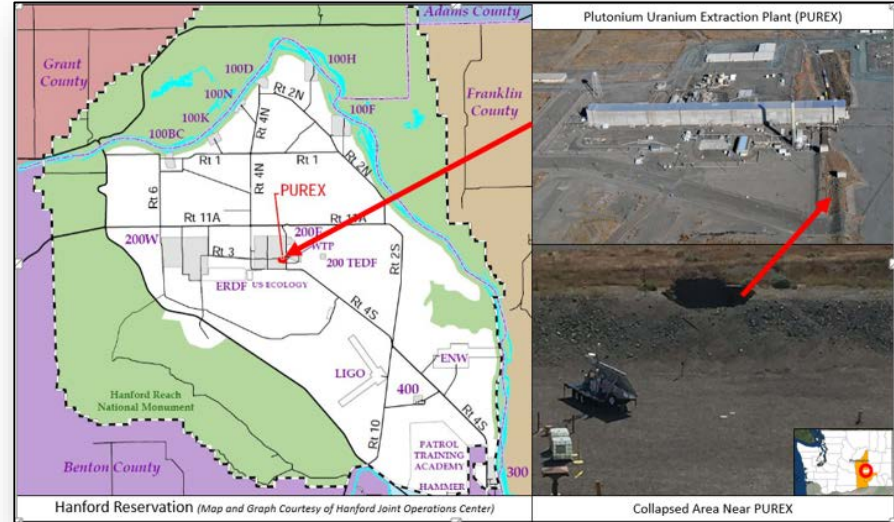
- Incident is moving from the response phase to the recovery phase
- Site emergency has been terminated

Impacts

- Workers have safely left the site except for personnel essential to the recovery plan
- After extensive testing, there has been no indication of worker exposure or airborne radiological release to the outside environment
- DOE Secretary has every confidence in the dedicated experts on the ground at the Hanford site
- Tunnel collapse has been stabilized with soil backfill
- No fatalities or injuries
- No local evacuations

Response

- WA EOC at Full Activation
- FEMA Region X RWC returned to Watch/Steady State
- FEMA Region X LNO returned to Region
- FEMA NWC remains at Watch/Steady State



Tropical Outlook – Eastern Pacific

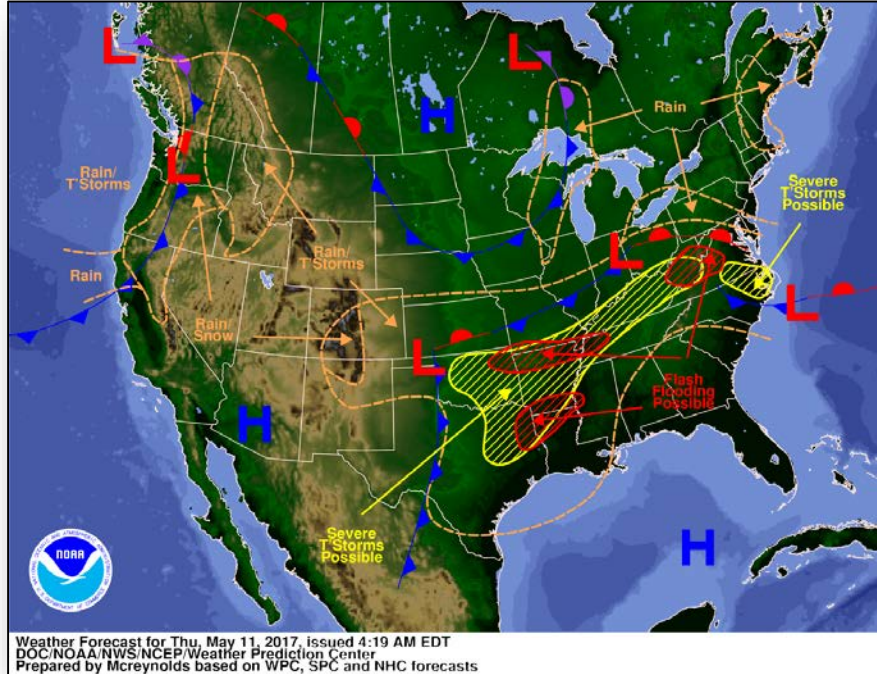


Tropical Depression Adrian (Advisory 7 as of 5:00 a.m. EDT)

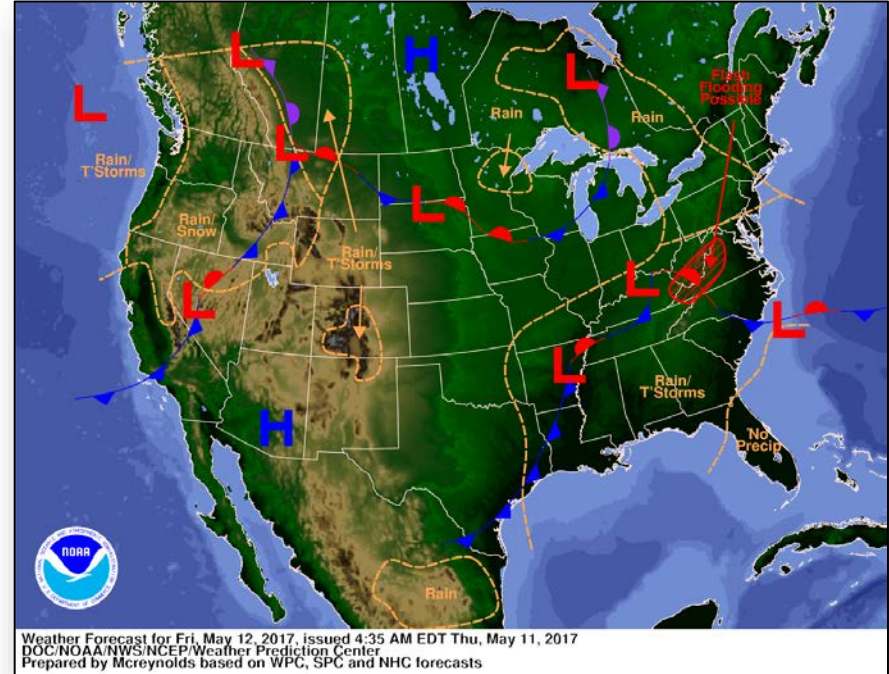
- Located 385 miles SSE of Salina Cruz, Mexico
- Moving NW at 7 mph
- Gradual turn WNW expected next day or so
- Maximum sustained winds 30 mph
- Expected to dissipate later this morning
- No coastal warnings or watches in effect

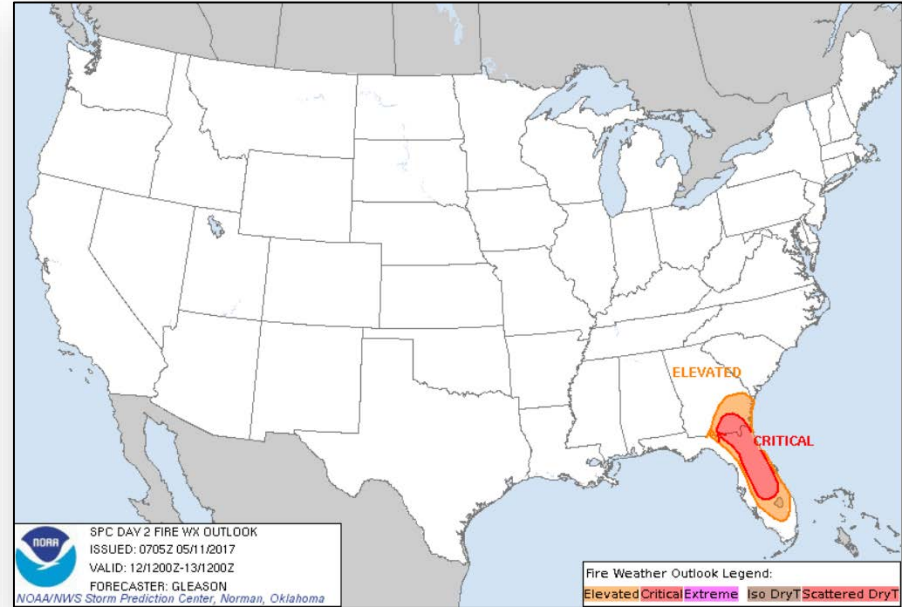
Precipitation Outlook – Flash Flood Risk

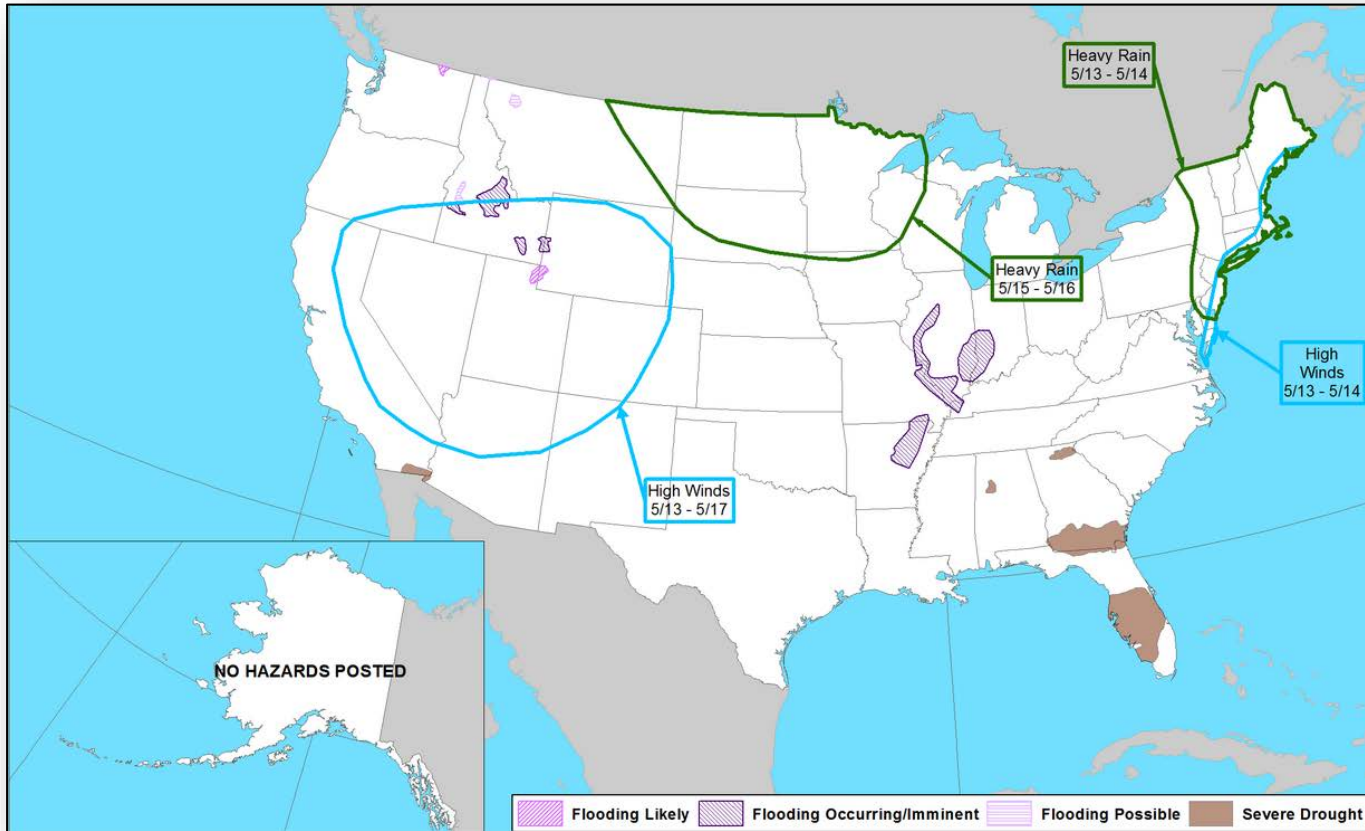

Strengthen Your Home

- If you plan to ride out the storm in your home, make sure it is in good repair and up to local hurricane building code specifications
- Many of these retrofits do not cost much or take as long as you may think
- Have the proper plywood, steel, or aluminum panels to board up the windows and doors
- Remember, the garage door is the most vulnerable part of the home, so it must be able to withstand the winds

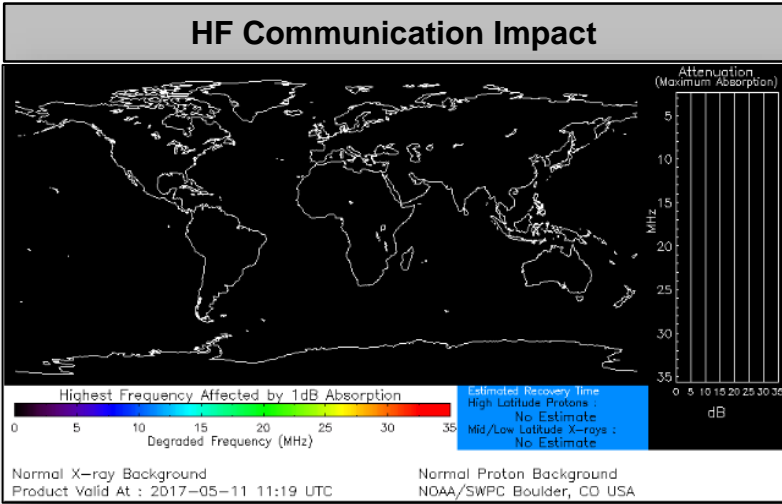

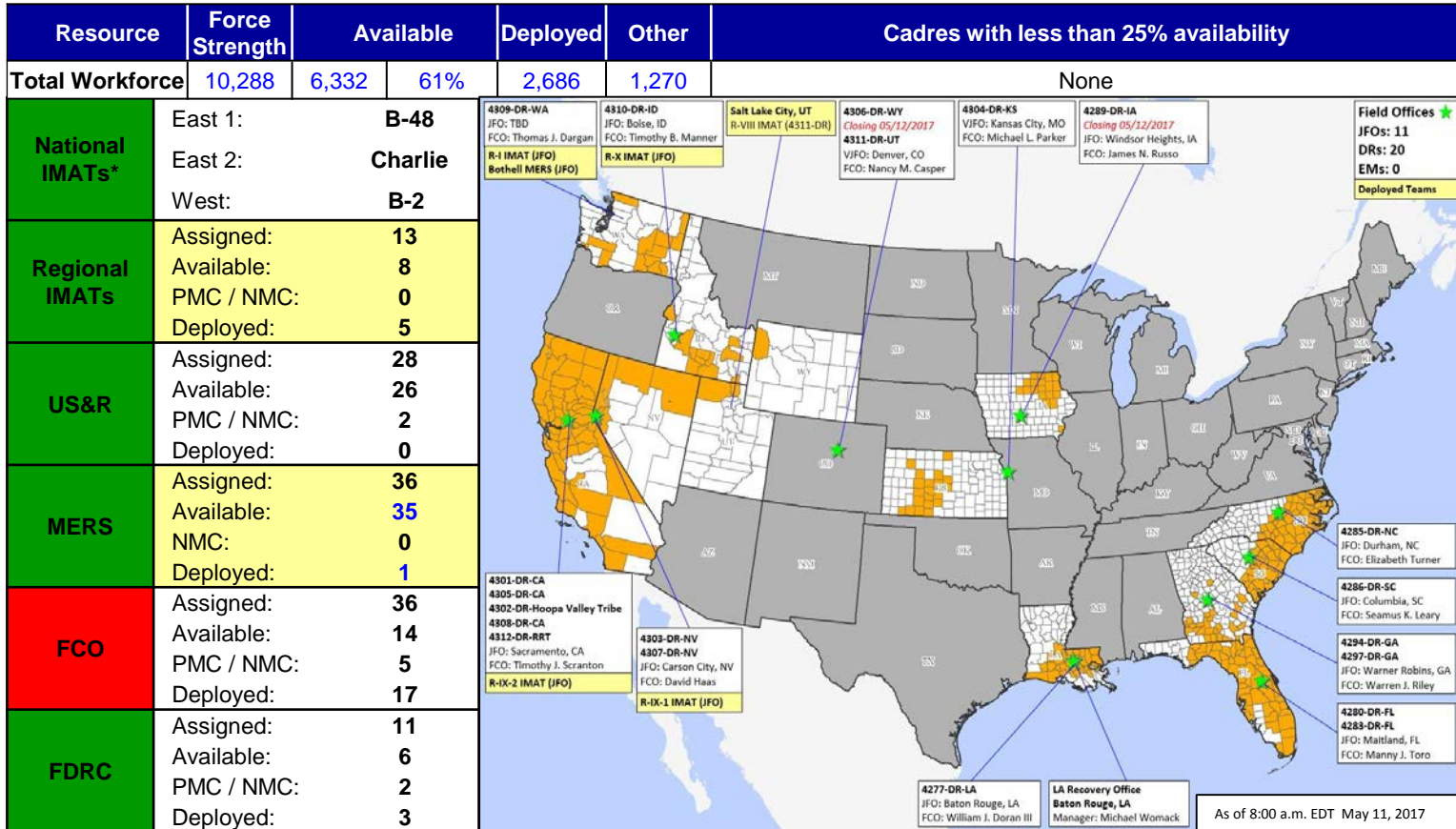
