Significant Activity – May 19-20



Significant Events: Severe Weather – Central U.S. FINAL

Significant Weather:

- Severe thunderstorms possible – Southern Plains to Great Lakes and Southeast
- Flash flooding possible – Southern Plains; Lower Mississippi Valley to Ohio Valley; Central Appalachians to Mid-Atlantic
- Rain and thunderstorms – Northern Intermountain to Northern Rockies and Central Great Basin; Southern Plains to Southeast, Great Lakes and Mid-Atlantic
- Rain and snow – Northern/Central Rockies and Northern/Central Plains
- Space Weather:
 - Past 24 hours: None observed
 - Next 24 hours: Moderate with geomagnetic storms reaching G2 level likely

Tropical Activity: No activity affecting U.S. interests

Earthquake Activity: No significant activity

Declaration Activity: None

Severe Weather – Central U.S. FINAL



Situation

- On May 16 and continuing severe thunderstorms with tornadoes, large hail and high winds stretched from the Southern Plains to the Great Lakes
- Strong to severe thunderstorms will be possible from southern Texas into the Mississippi and Ohio valleys this afternoon and evening ; isolated damaging wind gusts and hail will be the primary threats

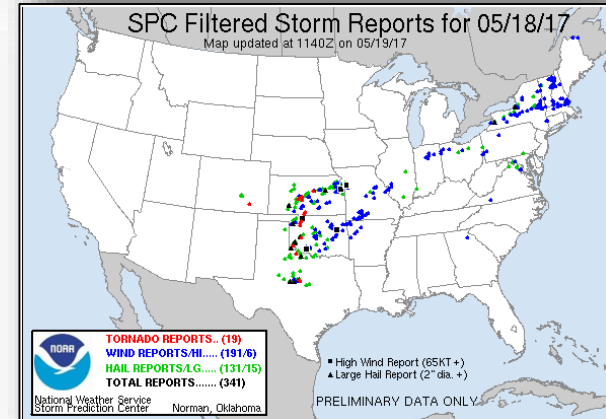
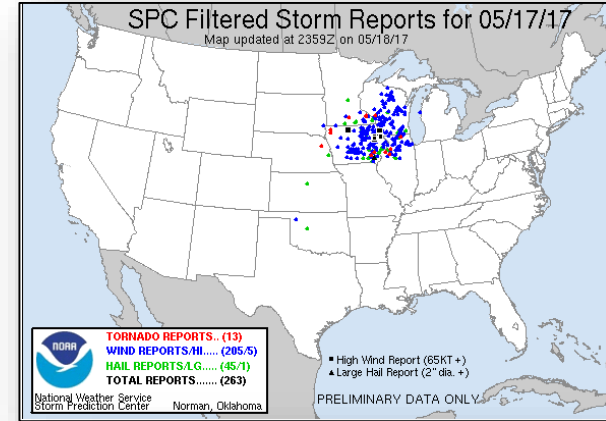
- No significant impacts in the last 24 hours requiring federal response
- Minimal power outages remain (As of 5:45 am EDT. Customer outage data is provided by the Department of Energy's EAGLE-I system. Comprehensive National coverage of all electrical service providers is not available.)

State/Local Response

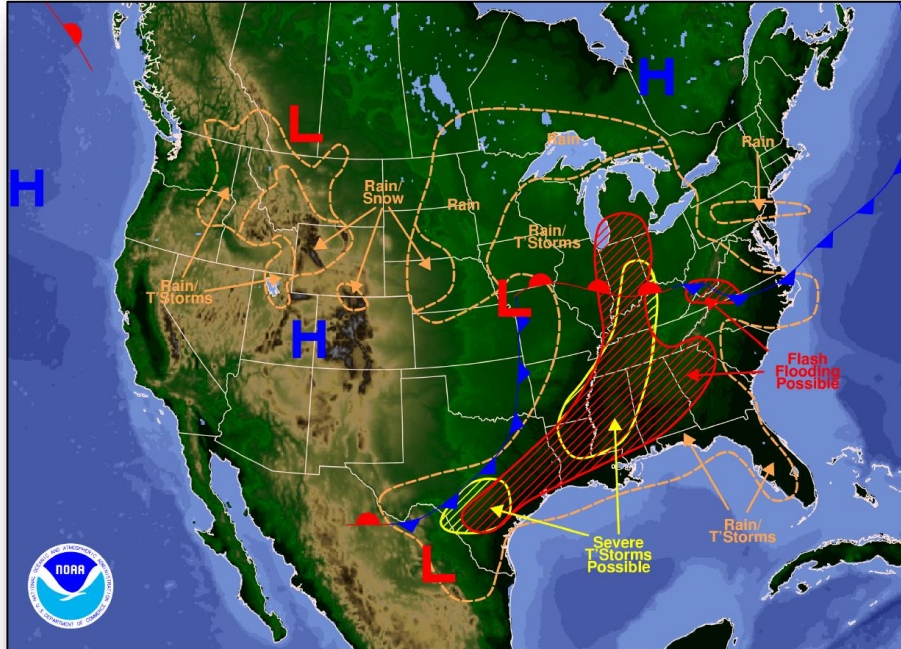
- WI EOC at Normal Operation; Governor declared State of Emergency for 3 counties
- OK EOC at Monitoring (severe weather)
- KS EOC returned to Normal Operations
- Shelters (ARC Midnight Shelter Count as of 4:31 a.m. EDT):
 - AR: 1 shelter open with 30 occupants
 - WI & KS shelters have closed
 - OK: 1 shelter open with 10 occupants

FEMA Response

- Region IV RWC at Watch/Steady State
- Region V RWC at Watch/Steady State
- Region VI RWC returned to Watch/Steady State; LNO demobilized from OK EOC
- Region VII RWC returned to Watch/ Steady State; LNOs demobilized from KS EOC
- NWC returned to Watch/Steady State

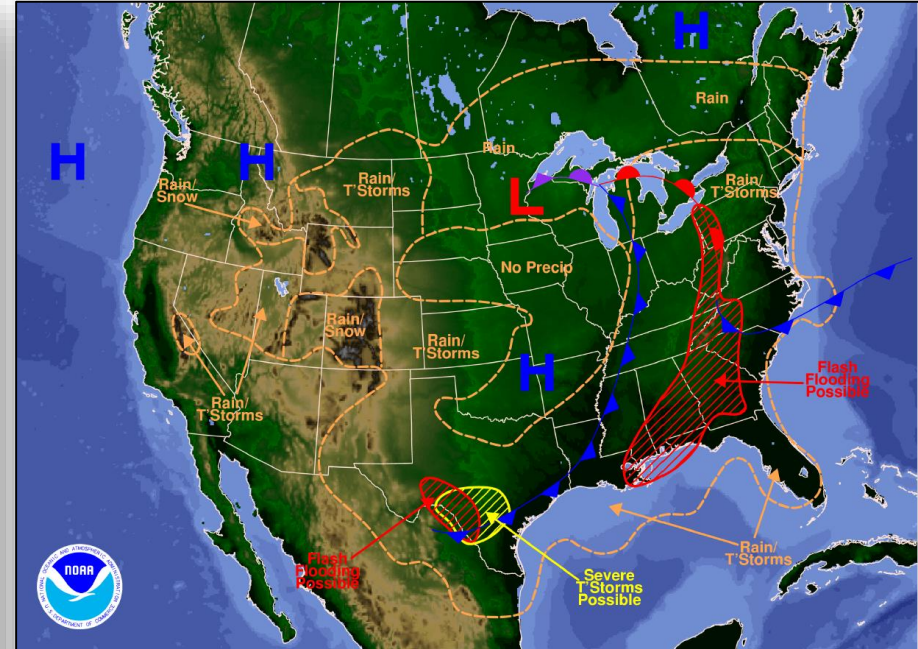


National Weather Forecast

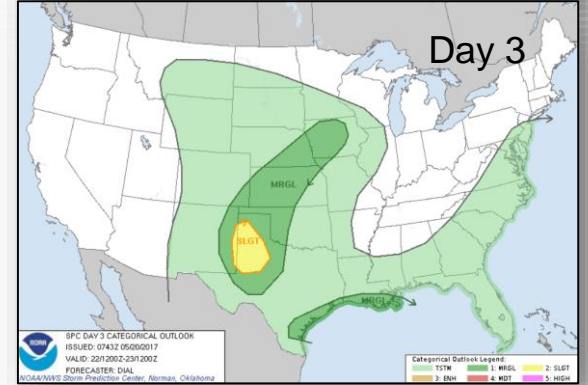
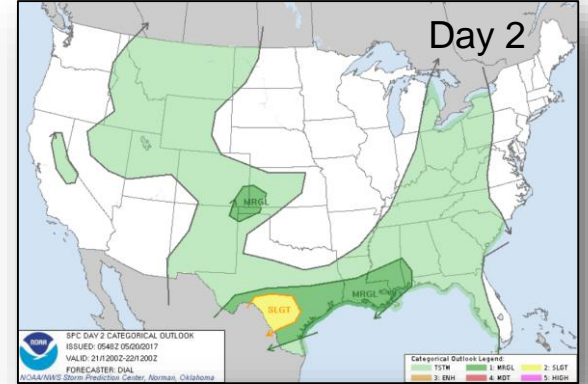
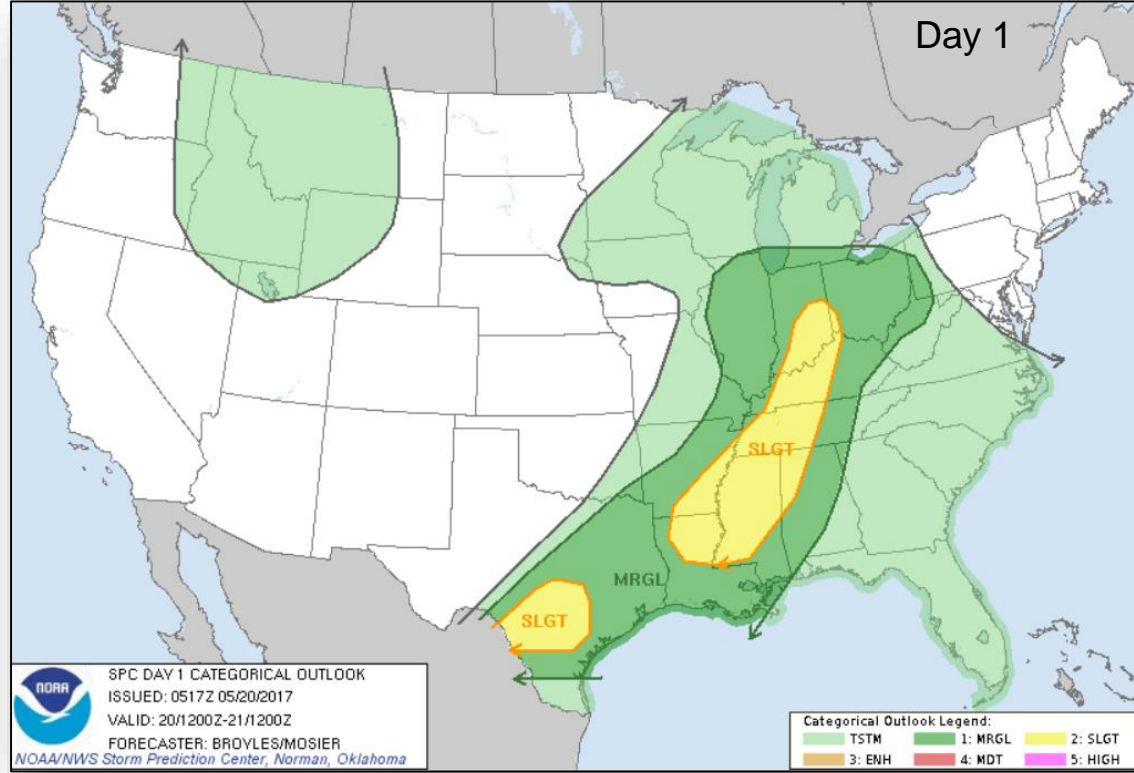

Severe Weather Outlook – Days 1-3



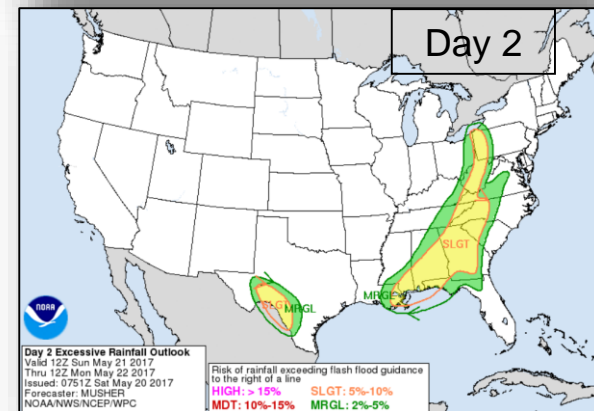
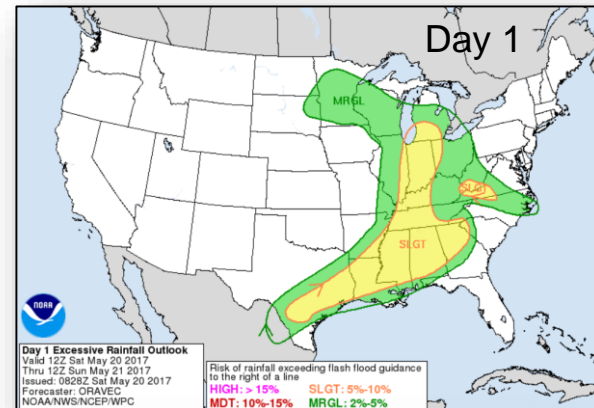
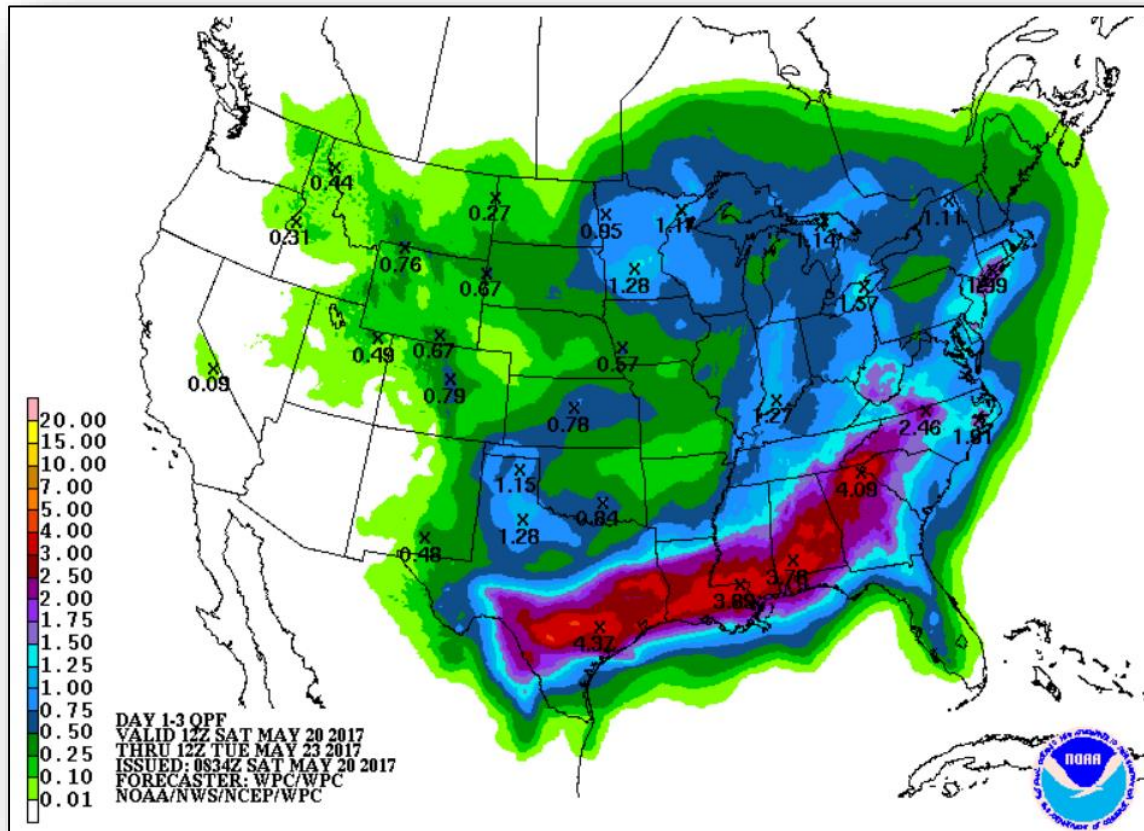

Precipitation Forecast / Flash Flood Risk



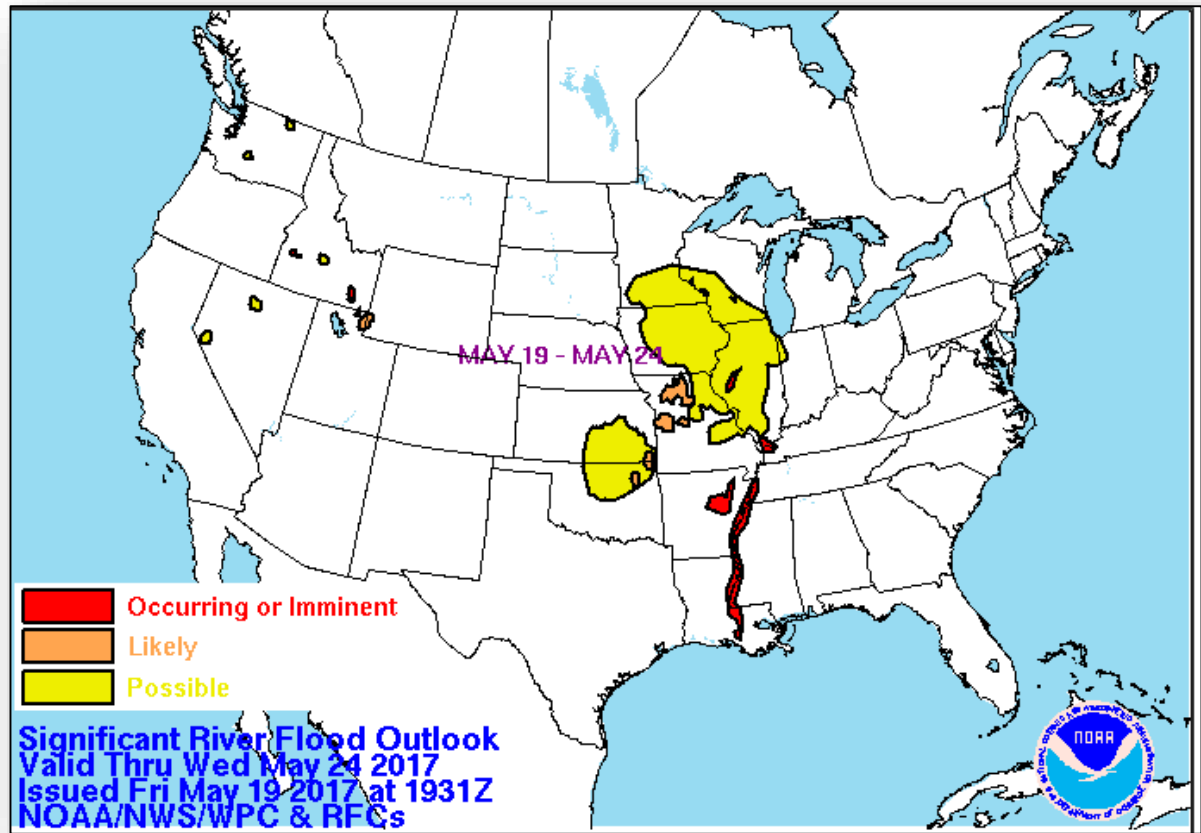

Significant River Flood Outlook



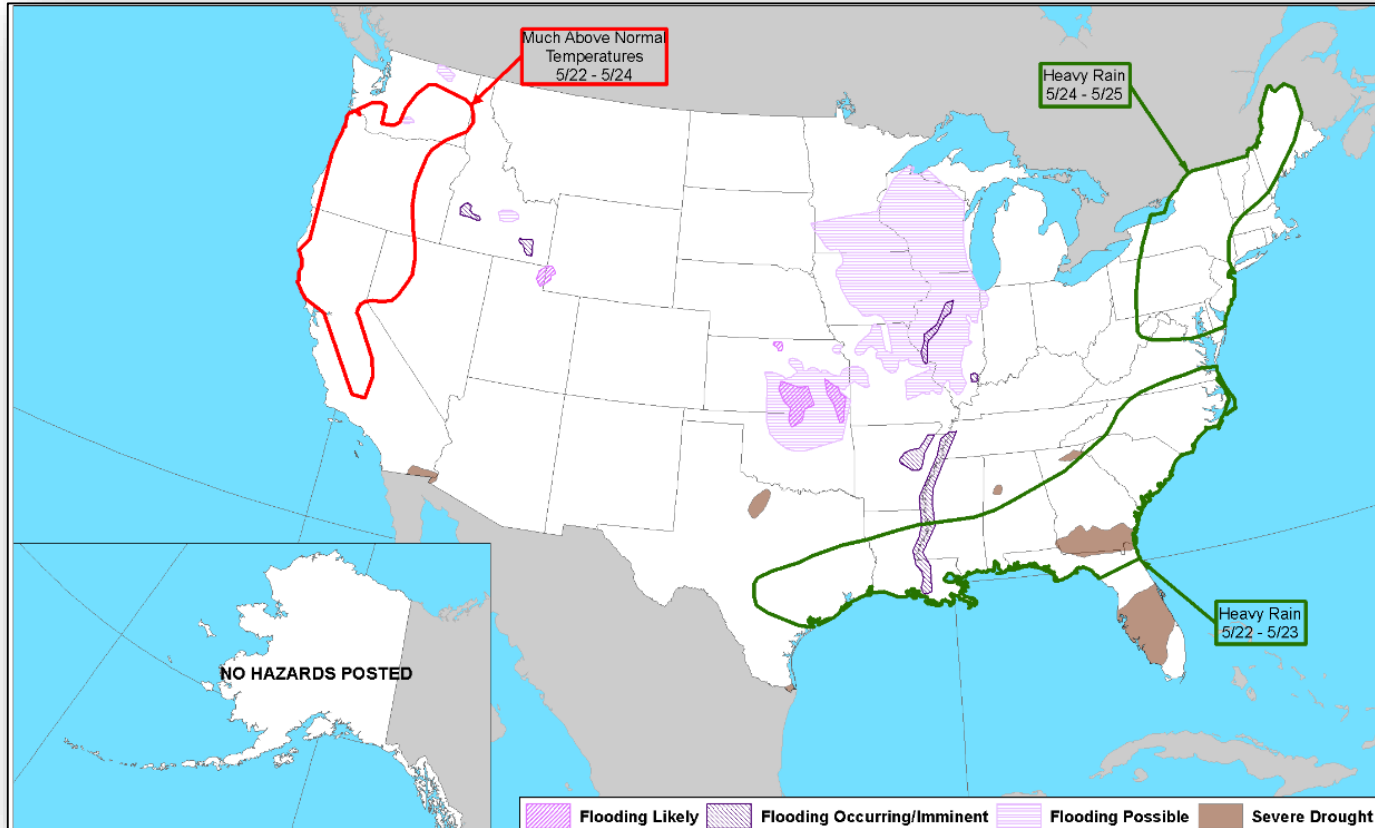
